Quinault Nation Welcomes Sacred Blueback Salmon in Annual Ceremony

In May, the Quinault Indian Nation gathered to celebrate the return of an essential cultural and ecological relative—the Blueback salmon.

Also known by its scientific name Oncorhynchus nerka, the Blueback is one of only seven kinds of sockeye salmon in the Pacific Northwest. What makes this species especially important to the Quinault people is its unique life history, which is specifically adapted to the Quinault River system.

Although Blueback salmon are relatively resilient compared to other salmon populations, their numbers have been declining since the 1950s. Key causes include the removal of oldgrowth forests, natural logjams, and large woody debris—all of which previously helped form stable, off-channel habitats critical to Blueback spawning success.

The Blueback is one of the first fish to return to the Quinault River each spring, helping to bridge a seasonal gap in fish availability. While some begin entering the river as early as December, the majority arrive in May and June. They then spend months maturing in Lake Quinault before spawning in November and December.

To honor their return, the Quinault Nation holds a salmon ceremony each spring—except in years when closures

are necessary for conservation. During the ceremony, a salmon is selected for a traditional blessing. It filleted horizontally to preserve the bones, a prayer is then said before the remains are carefully returned to the river and then the meat is respectfully fire-roasted and

consumed. Quinault Nation President Guy Capoeman described the ceremony as "a time to honor and welcome our relatives back home." In Quinault culture, salmon—especially the Blueback—are regarded as sacred relatives. They are more than just a

food source; they are an integral part of the ecosystem and a vital element of Quinault identity and survival. This ceremony not only honors ancestral traditions but also offers prayers for a strong and sustainable fishing season ahead

On May 5th, 2025, students, teachers, and community members came together in a powerful display of unity to raise awareness for Missing and Murdered Indigenous People (MMIP). Organized by Marquel Waugh, the

event aimed to educate and engage students while honoring those affected by the ongoing crisis.

"I prefer to use the term MMIP rather than MMIW," Marquel explained. "It's important to acknowledge and bring awareness to all Indigenous people who are missing or have been murdered—not just women."

The day began at 11:00

a.m. as elementary students, Queets Head Start, and Taholah Day Care joined together to walk two laps around the field. This symbolic gesture allowed younger children to take part in a meaningful way without being exposed to the heavier facts surrounding MMIP.

At 12:30 p.m., the school hosted an exhibit displaying student work and research on MMIP. The displays offered

students an opportunity to have their voices heard and to share what they have learned with classmates and the broader community.

At 1:00 p.m., everyone gathered in the gymnasium for a special presentation by Tyler Crossguns, Stephanie Terrell. Following the presentation, the entire group donned red shirts and walked through the village, singing songs in soli-

darity. The walk ended at the seawall, where participants shared reflections and healing words before returning to the school to conclude the day.

The event served as a reminder of the strength and unity within the community, as well as the importance of continuing to raise awareness about MMIP.

NOTICE IS HEREBY GIVEN that the BIA Taholah Agency Superintendent, as Trustee of Quinault Reservation Allotted Trust Lands, seeks a Power of Attorney from the above-named individual in connection with a proposed trust timber sale on allotment land held under the trust of the United States Department of the Interior pursuant to 25 CFR § 163.20.

Despite diligent search efforts, he cannot be located. Under federal law, the Secretary is authorized to proceed after notice by publication when an Indian owner cannot be located after reasonable effort.



I'm pleased to share that the state legislature has again invested in our village relocation efforts. We have secured the funding needed to clear Allotment 100,

keeping the momentum going in Queets. And they awarded funding to support continuation of the cleanup of the lower Village.

We also will have \$1.5 million to begin the important work of designing our own Long House. When we were in Olympia last March, we shared how critical a place where we can all gather and celebrate is for our culture, our spirit, our history, and the legislature listened. Thanks to the good work of our QDNR staff, contractors and consultants, legislators continue to provide \$2 million in funding for restoration of the Upper Quinault River, supporting the return of our iconic Blueback.

All told, after additional grants we've secured, the Nation will receive about \$8 million from the state over the next two years. This is on top of more than \$50 million we received in the previous two years for relocation efforts, the Quinault Wellness Center, land acquisition, and habitat restoration.

I hope you were not thinking I forgot you all! I have been busy as your secretary since the 2025 Annual General Council. April 6 – 11, I traveled to Chandler, Arizona to attend the 50th Self Governance Conference. I was so happy to be there and witness the presentations about all the Tribes' journey to becoming Self

Governance. The most inspirational was watching a short documentary of Former President Joseph DeLaCruz and the other Tribal Leaders that was instrumental with bringing Self Governance to Indian Country. I also saw President Capoeman, 4th Councilman Johnston, Julie Burnett, Director of Public Works, Alyssa Johnston Relocation Project Manager give a presentation on Quinault Indian Nation's Relocation Project for Queets and Taholah. They did a great job on telling our story. I was very proud of each of them contributing to discussion.

The focus of the conference Panels was discussing how the different tribes are having to deal with DOGE and Funding Reductions due to the current Administration. Secretary Robert Kennedy Jr. was a part of a Panel discussing the Department of Health & Human Services. He mentioned in one of his answers the current Administration is focusing on AI, and the goal is to have medical issues handled remotely. Meaning, people would not be seeing a medical professional in-person. That did not go over very well, the whole auditorium echoed with Boos.

May 5-8, 2025, was the Business Committee Reorganization Meeting. We discussed the 2 General Session Item from the Annual General Council Meeting, obtained our assignments to Subcommittees and Liaisons to Committees internally and externally.

I have been assigned to Education and Community Services (ECS) and Natural Resource & Community Development (NRCD) Subcommittees. The following are the Committees I am assigned as a Liaison either as a Delegate or an Alternate:

AGC 2025 General Session Item # 1 – Membership Fuel Discount from all QIN Gas Stations was approved by Voice Vote. On June 9, 2025, the Business Committee had approved Resolution 25-133-103 providing a thirty cent (.30) up to 100 gallons monthly discount for the 2025. Quinault Members.

Session Item #2 – Business Committee Office Space and minimum 32 hour per week in the office unless on Travel Status. Was approved by Voice Vote. Fortunately, at the time this item was presented the Business Committee had already begun construction on 4 office spaces for the full-time Business Committee Members found within the Administration Wing of the Tribal Administration Complex (Tribal Office).
















April Chitwhins of the Month - Teachings of Skunk Cabbage


6th grade Katalaya Mason








7th grade Dylan Mowtich Purser



Taholah Water Improvement, Upper Village

Three water towers are being constructed in the relocation area of Taholah. The three tanks will hold 474,000 gallons of water, which will provide water for the upper village, relocation areas.

Queets Relocation Design We have been working with Red Plains firm to plan and design the Queets village relocation. The plans should be complete the by the end of June 2025. Allotment 100 has been identified as the site for Queets relocation. We will begin clearing Allotment 100 hopefully this summer.

Two of the victims were in critical condition and two were ambulatory.

Emergency Management conducted a tabletop exercise with programs and provided great training and skills to a wide variety of staff. They continue to work with the Nation's leadership provide scenario-based training to develop necessary skill sets that will allow programs to respond seamlessly when an event occurs.

EMS continues to work very hard to provide services all over the reservation. While understaffed they continue to cover District 4 calls while still covering calls for Taholah, and Q-Village. This has severely strained their staffing capacity, but I am proud of their commitment to the Nation and our people as they provide this vital service.

Animal Control: Public Safety is still working to fill two open Animal Control positions. In the interim, Law Officers will continue to respond to dangerous animal complaints and address them appropriately. Pets for Life continues to provide necessary pet services to the community and we are grateful for all the hard work and services Coordinator Kira Ferrier-Curley continues to provide to the community.

Education

OIN Education the Boys & Girls Club had a successful Spring Quarter, supporting Youth Opportunity Program (YOP) students and college students. During this quarter, QIN Education funded 79 Quinault students attending colleges across the country. The Education Department plans to collaborate closely with the Grays Harbor College TRIO Program and the Native Pathways Program this coming fall. We aim to establish quarterly meetings and work together with the GHC board to increase awareness of QIN Education.

The Boys & Girls Club will begin their summer programming on June 23, 2025, from 12 to 2 PM in Taholah. This will be our summer kick-off event, held at the Taholah High School softball field. The Queet Boys & Girls Club Summer kickoff event will take place on June 24, 2025, from 12 to 2 PM pm at the Queets baseball field.

We celebrated the graduation of several Quinault students this quarter, including both high school and college graduates. We hosted a recognition dinner for our high school graduates, and we plan to make next year's event even bigger (see page 16 for Quinault graduates

Recently, we hired a new Teen Center Cultural Specialist, Nicholas (Nick) Pittack. Initially in an on-call position, he has now accepted a fulltime role and is eager to create plans for the teens over the summer.

TERO

TERO has been busy with a new project through PAC Mountain working with our 18-24 youth. A more detailed article will occur in next month's Nugguam. As always TERO is busy working with contractors on or near the reservation with job placement for our TERO clients.

Also, we attained the Arts WA grant that will fund our Language Family Nights beginning in Queets in the Fall.

TANF

TANF is preparing for

camp. We are excited to be celebrating our 15th year of offering camp to our youth. Camp is July 13th through the 18th in Shelton WA. The Queets office site is being prepped, thank you to the QIN Construction Program. The program will be transitioning to US Bank to provide gift cards, monthly assistance payments and Diversion services. The goal is to streamline the payment and reduce the administrative process. The Intergovernmental Agreement process has begun. The agreement must be complete by Sept. 30, 2025. This allows the TANF Program to receive state funding and continue to provide services to the community. We currently have vacancies and are working with Human Resources to fill the positions. The Taholah Lead Caseworker, two Intake Specialists, and a caseworker are currently being advertised. We look forward to new staff joining the program as we continue to improve service delivery and provide services that fit the needs of the families. There are six youth that are graduating this year. Congratulations to the youth and the family that have supported

New Opportunities has hired a new coordinator. Gail Parker has been promoted into the position. Gail has worked for TANF for almost two years. Her knowledge of the program has allowed for a smooth transition. Gail will be providing services Monday and Wednesday in Taholah and Tuesday and Thurs-

days in Hoquiam. She goes to Queets one Wednesday out of the month. This may need to increase should the number of participants increase. Most cases being served include medical and treatment exempt. With those that are treatment exempt, staff have been working closely with the Quinault Wellness Center to support those in recovery. Thank you to the Wellness Center for the work they are doing.

Child Support

QIN Child Support Services program is located at 214 4th St. in Taholah. Our program can establish parentage, child support orders, or modify orders. We can also verify Treaty income and garnish, so orders are based on actual income not presumed. We can establish orders on individuals living on the reservation, or those who receive Public Assistance through OIN TANF. We can also refer cases to the State or other States. Museum

The museum is currently in its busy season, we receive visitors from all over. Currently we've had 100+ visitors since the beginning of May. We hosted a Q+A session with Architecture students from Washington State University as they plan to design the new phase of the relocation for the nation. We also received staff from Lake Quinault Lodge as we plan to co-host a tribal art exhibition. Museum staff have

also issued 46 cedar harvest permits.

We are excited to continue planning our new museum. The planning stage is in the process of being unfrozen and we will continue working alongside the planning and language department on designing the building. Looking forward to July we are planning our group trip to Bowerman Basin (aka Grays Harbor Wildlife Refuge) to harvest sweetgrass."

Early Learning

This has been a busy quarter for the Early Learning program. Graduation for our head start students is always a joyous time for our staff and parents as they see the children ready for kindergarten. We had five graduates in Queets this year. Their graduation theme was centered around princesses, and they were all magical and beautiful. Taholah head start graduates had a Circus theme with twelve graduates at their ceremony. We appreciate our parents that entrust us with the learning and cultural activities that our program has to offer. We also appreciate the time and effort our parents and staff put into making the graduation evening a special event for our kiddos.

We will start our enrollment for next year's Head Start program soon. Look for posted notices.

Tips to Help Your Picky Eater

Good nutrition is important for young children to help them grow healthy and strong. Children need a variety of nutritious foods each day for healthy growth and brain development. Early eating experiences can also affect how people eat as they get older. This is why it is important to introduce young children to healthy foods, including a variety of fruits and vegetables.

Follow these tips to help your picky eater try new foods.

- Try eating the food first to show them you like it. Then, let them try it.
- Make funny faces with the food on their plate. It may help them get excited to eat it.
- Give them a choice of different foods to try. Let them decide which one to try today.
- Serve new foods with foods you know they like.
- Try freezing small bites of leftover foods. You can use these later.
- Wait a couple of days before offering the food again. It can take more than 10 times before your child likes it.


As children get older, they may start refusing foods they used to like or start showing signs of being a picky eater. Favoring just a couple of foods or not wanting foods to touch each other on the plate are normal behaviors. These behaviors often go away by the time the child is about 5.

Giving your child foods with a variety of different <u>tastes and textures</u> can help them learn to accept and like a variety of foods. You can let your child try a variety of textures including:

- Smooth (strained or pureed).
- Mashed or lumpy.
- Finely chopped or ground.

Start with smooth or mashed foods first and then move towards finely chopped or ground foods as they get older. This can help your child develop chewing skills, as well as fine motor skills like pinching and picking up food with their fingers. Be sure to offer foods in the right size, consistency, and shape for your child's age and development to help prevent choking.



Unprecedented Storm Damage Forces Indefinite Closure of Quinault RV Park and Marina

The Quinault Marina at Ocean Shores is filling in with silt and sand now blocks the entrance into the marina from the bay.

Following an exceptionally harsh winter, the Quinault RV Park and Marina in Ocean Shores have sustained extensive damage, leading to indefinite closure. Violent coastal storms wreaked havoc on the property, compromising the RV park's essential infrastructure, including major damage to sewer and electrical systems. Severe beach erosion also eliminated several waterfront RV sites, drastically altering the landscape.

The destruction has left the grounds with significant challenges to operational recovery. Quinault Corporate has worked closely with the City of Ocean Shores to address beach erosion and the increasing sediment into the marina making it unsafe/unusable for any vessels. Quinault Corporate is assessing our financial responsibility and costs associated with damaged infrastructure.

Given the magnitude of the damage and lingering uncertainty, Quinault RV Park and Marina

will remain closed for the foreseeable future. Quinault Corporate management will continue to review avenues for its reopening but must prioritize safety and the long-term viability of the property. Quinault Nation Enterprises management and Quinault Nation Enterprise Board remain committed to updating the public as the situation progresses and express deep gratitude for the community's ongoing support.

Damon Point has been closed since late January and the city of Ocean Shores declared an erosion emergency in early February. Also in late January, Ocean Shores commissioned the construction of a temporary cobble berm to replace a sand berm along the south shore that had suffered storm damage. Further efforts to combat the effects of coastal erosion are slated to begin in 2026 or are stymied by the loss of federal grant programs.


He lived his 33 years



in the event that a child has dietary needs Darrin makes adjustments to meals as needed.




Nation. He also has experience as a guide and along with previous time as a deckhand. In his free time Kobe likes to explore nature and is also into physical fitness.

Rebecca Black Interview - May 5, 2025

Rebecca Black descends from the Quileute Tribal family of Blacks; she is an enrolled Quinault member. Her family is the Carl Black (Violet Bright) family, which includes Gram Beatrice Black (Johnson Black). Today she shares part of her personal history of being a child of what is known as the SCOOP generation. What

is that? It's tribal children that were taken from their families and adopted to non-tribal families. Becky (as some of us call her) is one of those children that was taken from her family home just as her mother was. Who was also one of these children. FYI this was all pre—Indian Child Welfare Laws.

As I understand part of

this important message is, many tribal members were literally scooped up from their villages and taken away. Some of the children were walking within their village streets or were attending school and were literally stolen from their families. Neither a mom nor a grandmother knew when this was happening.

During the time frame when Becky's mom was literally stolen and stuffed into a car and relocated out of the area. Soon after she was adopted by a non-tribal family. Many of the tribal elders did not speak English and didn't understand what was happening. Many felt that this type of action taken by the Government was happening and it was very similar to tribal members that were whisked away to various boarding schools. When children were taken, there were ads and pictures put in magazine ads depicting "save the poor Indian waifs", they are available for adoption, take them to your home. The children were placed into a building called an orphanage; many tribal members were familiar with the old Cushman hospital. Her Mom had the bad ex-

perience of being kicked out of her adoptive home when she got pregnant at the age of 13. Her Mother ended up livings in the streets of Portland and Seattle. Thankfully in later years there were tribal leaders elected and non-elected that demanded change, people like Ramona Bennett and Hank Adams were strong advocates for Indian children. She did not know Joe DeLaCruz nor Billy Frank but felt that from everything that she read or heard, they were great leaders that were there for the people. Many years later the ICWA (Indian Child Welfare Act) law was adopted. Families were discouraged from notifying Tribes or families that they were adopting Native children; they were fearful that families or Tribes would interfere via a legal process. There are some people that still today believe that this law is not adhered to.

Becky being a strong Quileute/Quinault woman did not allow this childhood experience from destroying her. She admittedly had an alcohol problem and fought and beat that addiction. In later years she was able to reconnect with her mom who gave birth to her,

it took perseverance to finally locate her. The long short story is that Becky has been able to reconnect with her family from LaPush. Her cultural and spiritual beliefs guided her in many ways. She feels strongly that drugs and alcohol is not the way we heal, it's who you are as native person that guides you. Spirits and prayer can protect and heal you.

Today she has strong beliefs about participating in Annual Meetings and trying to make the best decisions that help all the members. She and her family are involved in tribal culture in various ways, they attend canoe journeys, (grandsons have pulled) participate with the songs, and make their traditional attire. She absolutely loves any seafood and would love some seal oil. And is anxiously waiting for the Makahs to catch their next whale, she would love to eat some.

"The interviews presented in the Nugguam are brief highlights of the interview we do. The interviews are video recorded and at some point will be accessible to all tribal members". - Pearl



Federal funding cuts threaten tribal treaty rights

Tribes in Western Washington are already seeing the impacts of presidential executive orders on funding that supports the management of treaty-reserved resources and the region's robust economy.

These funding cuts, coupled with mass layoffs of the federal scientists we work with to manage and protect our treaty-reserved resources, are contrary to the federal government's trustee obligation to protect and implement the treaties we signed in the 1850s, reserving the right to fish, hunt and gather in our traditional areas.

Our treaty rights have been upheld twice by the U.S. Supreme Court and are protected as property rights under the Fifth Amendment. In addition, the 2022 PUGET Save Our Sound Act legally obligates federal agencies to coordinate with tribes to set priorities to recover Puget Sound, designated an estuary of significance by the National Estuary Program.

Harvest management

Planning annual fishing seasons is challenging enough as tribal and state co-managers must divide up diminishing numbers of harvestable salmon. This year was even more difficult because of the hundreds of jobs eliminated at the National Oceanic and Atmospheric Administration (NOAA). Those who remained were constrained by budget cuts and agency reductions.

So far, NOAA has received only half the annual funding it needs to implement ocean sampling programs, conduct chinook stock assessments and support habitat recovery efforts from Oregon to Alaska. This reduction impacts state and tribal salmon management and recovery efforts at a magnitude that exceeds our ability to find other funding to make-up the shortfall.

Managing sustainable fisheries depends on NOAA's participation, which includes analysis and production of compliance documents. Even slight delays to these reports could cancel a tribal or state fishery, costing thousands of jobs, harming the national and international food supply, diminishing the exercise of our tribal treaty rights, and devastating the marine-based economy.

Another program that could be cut is the Pacific Coast Salmon Recovery Fund, which would endanger more than 70 tribal jobs essential to fisheries monitoring and evaluation that support our treaty

rights and the region's fishing economy.

Hatchery programs

Federal cuts to NOAA and the Bureau of Indian Affairs also threaten the hatchery programs that provide more than 80% of salmon harvested by tribal and nontribal fishers in the Pacific Northwest. Tribal hatcheries release about 40 million salmon each year. Without federal funding, we won't be able to maintain and upgrade aging facilities, implement hatchery management plans, or conduct the research and monitoring needed to rear

healthy broodstock.

Also in danger is the U.S. Geological Survey Ecosystems Program, which includes the Fish Health Program at the Western Fisheries Research Center. This work is essential to ensuring we have the most up-to-date knowledge about pathogens to prevent their spread in salmon at all life-stages.

Tribal sovereignty

Our tribal sovereignty to manage our own treaty-protected natural resources depends on funding from the Environmental Protection Agency (EPA), such as the Puget Sound Geographic Program, to support research and monitoring. EPA funding also supports our participation in bottom-up, cross-agency partnerships with federal, state and local agencies to steward fishery and wildlife resources.

Even without cuts to specific programs, reductions in staff could delay disbursement of funds that enable tribes to participate in necessary processes to protect our treaty-reserved rights. These include intergovernmental fishery management processes, U.S./ Canada fishing treaties, fisheries forecasts, watershed analyses and numerous other scientific exercises critical for adaptive management of treaty-reserved fishing.


Federal funding supports tribes' capacity to engage in these critical processes that are essential to upholding treaty rights and protecting resources such as salmon and shellfish—both economic drivers in the Pacific Northwest. Investing in salmon recovery directly and indirectly supports jobs in restoration projects, fishing, transportation and tourism.

Government support of tribal natural resources management is not optional. The United States has a trust obligation to protect tribal treaty rights to fish, hunt and gather as we always have. That includes providing the funding we need and conducting necessary administrative functions in a timely manner to allow us to exercise our treaty rights and protect natural resources for the next seven generations.

Are you an elder interested in being interviewed?

We continue to interview the elders. We have interviewed members that are no longer enrolled in Quinault. Many of them grew up on the Quinault Reservation, either in Queets or Taholah. Or their involvement or participation in tribal activities was important to the Quinault Nation. We believe that each interview has been such an important part of history and wisdom that they are passing on. And the knowledge that our elders possess and have shared is an important piece of who we are. And we absolutely love their sense of humor.

Trump pulls US out of agreement to help restore salmon in the Columbia River

SEATTLE — President Donald Trump on June 19th pulled the U.S. out of an agreement with Washington, Oregon and four American Indian tribes to work together to restore salmon populations and boost tribal clean energy development in the Pacific Northwest, deriding the plan as "radical environmentalism" that could have resulted in the breaching of four controversial dams on the Snake River.

The deal, known as the Resilient Columbia Basin Agreement, was reached in late 2023 and heralded by the Biden administration, tribes and conservationists as historic. It allowed for a pause in decades of litigation over the harm the federal government's operation of dams in the Northwest has done to the fish.

"Donald Trump doesn't know the first thing about the Northwest and our way of life — so of course, he is abruptly and unilaterally upending a historic agreement that finally put us on a path to salmon recovery, while preserving stable dam operations for growers and producers, public utilities, river users, ports and others throughout the Northwest," Democratic U.S. Sen. Patty Murray of Washington said in a written statement. "This decision is grievously wrong and couldn't be more shortsighted."

"The goal of this effort is to reach hundreds of teachers and thousands of students in the Northwest with the voice of the tribes, and the lesson of environmental sustainability," said Steve Robinson, curriculum writer, filmmaker and longtime tribal advocate.

The content of the www.Thisisindiancountry.org

website will continue to expand, and keep pace with the ever-changing impacts of climate change, and is free and easily available to educators, researchers and all others, says Robinson.

Teachers from around the Olympic Peninsula came to Ouinault Nation on June 16-17 to learn about "Tribes & Climate Change." The educators' workshop was hosted by Quinault Nation and produced by the Indigenous Climate Project, a partnership of nonprofits Pacific Education Institute (PEI), Washington Wild and This Is Indian Country (TIIC), the latter organization co-founded by the late great Billy Frank Jr.. M'liss Dewald, Quinault COO, co-emceed the event with Kathryn Kurtz, Executive Director of PEI..

The group of about 30 teachers and staff was welcomed by QIN President Guy Capoeman. Following the welcome President Capoeman joined Chairman Douglas Woodruff of the Quileute Tribe, Ed Johnstone, Quinault and Chairman of the Northwest Indian Fisheries Commission and moderator Kat

Brigham, former Chairwoman of the Confederated Tribes of Umatilla and Special Counsel to the Affiliated Tribes of Northwest Indians on a panel to background the teachers on the impacts of climate change and other environmental challenges and the ways tribes are providing leadership in response to these challenges.

Participants were briefed about a new curriculum regarding these issues, available to them and the public on the website at:

www.thisisindiancountry.org. The site also features 28 interviews with tribal leaders, the new video, "Climate Story" and an interactive map providing background information about tribes throughout the state. Elsewhere on the site are never-before-seen videos of tribal leaders, including Billy Frank, Jr., Hank Adams, Joe DeLaCruz and others.

Larry Workman, long-

time Nugguam Editor and Communications Manager for Quinault Nation, showed participants a slide show depicting the history and current environmental status of QIN. The rest of the afternoon was devoted to break out circles and classroom planning, coordinated by PEI staff. An extended version of the "Climate Story" video was presented by Michael Harris of TIIC, an award-winning filmmaker who worked with Billy Frank, Jr. to start the TIIC program.

Workman took the reins of the workshop on a second day by guiding a day-long bus tour of the QIN's sites and environmental programs.

This was the second of three of these workshops, following an event hosted by the Tulalip Tribes last summer and preceding another on June 23-24 hosted by the Suquamish Tribe. Another is planned for eastern Washington next year,

nated a long-term lease on a hillside parcel about one mile inland from Neah Bay to build the new school with a capacity

for about 600 students. District Superintendent Michelle Parkin said she harbored a lot of concern last winter upon reading about the budget shortfalls the 2025 Legislature had to grapple with.

"It's such a relief," the school relocation funding came through, Parkin said. "Our children are going to be safe."

Seismic Program

Tharinger said the Legislature's budget writers decided to be more prescriptive in the newly signed state budget by steering specific sums to projects ready to go in the most vulnerable coastal school districts. Hence, the green light to break ground in Ocean Shores,

Overall, the seismic safety program was renewed at a lower level than the state superintendent asked for in light of many other competing priorities for state construction dollars.

"It's pretty exciting to have avoided a tragedy and to be able to start building schools in safer places," Tharinger said.

state superintendent's office, Newman wishes the Legislature had funded additional school seismic projects in the new budget. Since 2021, he's seen statefunded earthquake retrofits through to completion in Centralia, South Bend, Boistfort and Marysville with Cosmopolis Elementary on deck to receive seismic strengthening this summer.

"We were happy with the funding level we received from the Legislature," to now lift the highest priority schools out of the tsunami zone, Newman said in an interview last week.

Washington state has long lagged behind neighboring West Coast states and provinces in addressing earthquake risk in school buildings. The Oregon Legislature, way back

in 2005, created a school seismic retrofit grant program on the scale now underway from Olympia. The provincial government of British Columbia started a seismic mitigation program for schools in 2004 and has shelled out more than \$1.9 billion since then.

Earthquake risk mitigation can also be done with local funding, which is how larger and wealthier Washington school districts have replaced or modernized the majority of their buildings to withstand strong shaking. But small and rural districts with limited tax bases and tax-averse voters usually have trouble with that approach.

Waiting years in line for state grant funding for seismic upgrades is a gamble, but there's a financial incentive for districts: taxpayers statewide foot the bill for at least twothirds — if not close to 100% — of the school reconstruction costs.

"We know that districts have struggled to pass local bonds and levies to modernize their school facilities," Newman said. "It's a big lift to address all the seismic needs of aging school buildings."

School relocation funding on the Olympic Coast

Teachers and staff in low-lying schools along the Pacific Northwest coast face an unusual extra responsibility alongside educators' usual duties: can they herd the entire student body to higher ground on foot in 20 minutes or less to escape a tsunami?

It's a daunting challenge with the highest possible stakes should an offshore earthquake unleash a wall of incoming seawater. The last megathrust earthquake to hit the region was in 1700, and the Northwest is now in the window for the next magnitude 9.0+ Cascadia fault quake and tsunami.

"It's something that's always on your mind. You try not to let this take over," said North Beach School District Superintendent Richard Zimmerman.

Funding

The Washington Legislature allocated \$151.5 million in the recently passed state construction budget to relocate three coastal schools out of the tsunami zone and build a refuge tower at a fourth. Zimmerman's district is one of the beneficiaries, along with the Taholah, Cape Flattery, Ocean Shores and Pacific Beach schools.

Taholah

The relocation of the Ta-

holah K-12 public school is part of a larger, years-long process led by the Quinault Nation to move much of the lower village of Taholah about three-quarters of a mile uphill, out of danger from increasingly common floods, storm surges and a future tsunami. The new school will eventually be surrounded by neighborhoods, parks and ballfields to be built

on freshlycleared forestland. Taholah Superintendent Herman Lartigue Jr. said he hopes to welcome roughly 200 students to their new quakeready school in 2027. He said the use of cedar planking on the outside of the school and exposed cedar beams and columns inside — as well as installations of tribal art would give the building a distinctive appearance.

"This building is going to be indicative of the culture. It's great," Lartigue said.

Other Coastal Schools

The Cape Flattery School District is making a parallel push to incorporate tribal culture in the new Neah Bay K-12 campus, which will replace an elementary school and secondary school at sea level on the Makah reservation. The groundbreaking is tentatively scheduled for mid-July, with move-in anticipated in mid-2027.



Timber Train shows vintage movie film of railroad logging and the lack of safety measures. 



On a bright, beautiful day filled with spirit and community, the Coastal 29 Project held a traditional blessing ceremony at the Kiewit Construction site, marking a meaningful milestone in the effort to remove fish passage barriers along the coastline.

The event brought together tribal leaders, project partners, and community members in a shared moment of respect, prayer, and cultural connection. The ceremony was held to bless the land and water, and to ensure protection and safety of all construction workers as the restoration moves forward.

A powerful and heartfelt prayer was let by Quinault Elder Tiki Rosander, whose words reminded all in attendance of the deep spiritual work being done. The project team extends a heartfelt thanks to Francine Mail for bringing

Tiki to the site and making the blessing possible.

Cleve Jackson, fisheries spokesperson for the Quinault Indian Nation, also contributed to the ceremony by singing a traditional song, offering both cultural grounding and spiritual strength to the mo-

The Coastal 29 Project is a coordinated effort to remove fish barriers and restore vital spawning habitat for salmon and other native species. For tribes like Quinault, this work is both an environmental necessity and a cultural obligation - restoring ancestral waterways is key to fulfilling treaty rights and protecting future generations.

As the ceremony closed, a sense of unity and reverence lingered in the air-carried by the song, the prayer, and the shared hope for healthy streams and safe workers.

Big Changes on US 101 within the Quinault Reservation: Six Fish Barriers to Be Removed


Work has started on US 101 Queets between Lake Ouinault and Queets. Be prepared for delays along this section of US 101 The Washington State Department of Transportation (WSDOT) is in the process of a major project to remove six fish passage bar-

Fish barriers—like old or poorly designed culverts under roads-can make it hard or even impossible for salmon and steelhead to swim upstream. Since launching its Fish Passage Program in 1991, the department has helped reopen more than 1,000 miles of fish habitat across the state.

This new project is also part of a larger effort required by a federal court order to fix fish-blocking culverts in western Washington The six US 101 sitesy under construction, located between milepost 135 and 153 from now through early winter 2025. The \$64.4 million project will restore natural stream flows, giving fish better access to the places they've been blocked from for decades—good news for the environment and local communities.

What to expect on the road:

Construction will take place weekdays from 7 a.m. to 5 p.m., with some weekend work. In May and June, crews built temporary single-lane bypass roads. thatNow, drivers will see 24/7 traffic lights and reduced speed limits of 25 mph at each site. There will also be measures in place to protect the surrounding environment during the project.

Sen. Murray, Rep. Randall reintroduce Wild Olympics bill


Patty Murray (D-WA) and U.S. Rep. Emily Randall (D, WA-06) reintroduced the Wild Olympics Wilderness & Wild and Scenic Rivers Act, legislation that would permanently protect more than 126,500 acres of Olympic National Forest as wilderness and 19 rivers and their major tributaries — a total of 464 river miles — as Wild and Scenic Rivers.

Designed through extensive community input to conserve ancient forests and pristine rivers, protect clean water and salmon habitat, and enhance outdoor recreation, the legislation would set aside the first new wilderness on

On May 13th, U.S. Sen. Olympic National Forest in over four decades and the first-ever protected wild and scenic rivers on the Olympic Peninsula.

> With a strong foundation of local support, the bill has made steady progress each successive Congress — passing the House with bipartisan support twice before and passing out of the Senate Energy and Natural Resources Committee last Congress for the first time in the bill's history.

> The Olympic Peninsula's old growth forests, freeflowing rivers and its diverse ecosystems and beautiful landscapes, is a crown jewel of Washington state





Unique Fire Lookout Built on the Quinault Reservation

June 1929: "A Douglas fir tree, well over 200 feet in height and about six feet in diameter, standing on a high knoll overlooking the entire northeastern part of the Quinault Indian Reservation has been made into a unique fire lookout station by a co-operative arrangement between the Hobi Timber Co. and the forestry branch of the United States Indian Service. The lookout station proper is believed to be the highest from the ground in the United States, for the floor is 170 feet from the ground. The construction of this lookout station presented peculiar difficulties, for not everyone can climb 170 feet from the ground, to say nothing of constructing a seven by seven house that is a distance from terra firma. The tree was topped by high climbers at a point about 176 feet from the ground, and a house about seven feet square was built, leaving about four feet of tree trunk sticking up through the floor. An Osborne fire finder was mounted on the tree trunk at the convenient height of four feet above the floor of the house. Four railroad ties were set in notches in the tree and securely bolted in place, and two by eight timbers, seven feet long were nailed on all four sides of the ties, and the house built upon this foundation. The side walls of the house were framed on the ground and hauled up to the foundation by means of a hand winch and block. Openings six by three feet were left on each side of the house and a window frame with three sliding windows was placed in each. The roof was shingled with redcedar shingles, and

house and did a large part of the actual construction, stood on the peak of the roof of the house (about 180 feet from the ground), after he had finished shingling the roof, and told the men working with him that he could see the Pacific Ocean, about 30 miles away. It will be a long time before Mr. Meyer's statement is corroborated.


The lookout house is reached by means of a rod and rope ladder, and the house is entered through a trap door in the floor. The ladder was built in the following manner: Inch steel rods, about three feet long with a hole in one end, were driven about eight inches into the tree about sixteen inches apart in such a manner that they made a winding staircase. The ends of these rods were threaded by a steel cable which was securely fastened to the top of the tree and tightened at the bottom of the tree by a chain block. As the steel cable was tightened the ladder was made very taut because the ladder winds around the tree and the pressure made


by tightening the cable tends to hold the ladder tight against the tree.

The tree is securely guyed by three wire cables which are fastened to the tree just below the house and tightened around nearby stumps. These guy lines were tightened by means of a chain block.

The lookout house is connected by telephone to the headquarters of the Hobi Timber Co., and because this station overlooks a portion of the Olympic National Forest, another telephone line has been built connecting the lookout with the district Forest Service ranger at Quinault. The lookout, who is an employe of the forestry branch of the Indian Service, has been furnished with an Osborne fire finder, properly oriented, high-power binoculars, and maps of the surrounding country, and will be on duty in the tree during the present fire season.

The Cook Creek lookout station is the second fire lookout completed on the Quinault Indian Reservation."




