# Governor Jay Inslee recognizes Vanessa Kowoosh from Queets in his final State of the State address



In outgoing Governor Inslee's final address to the people of the state of Washington, he covered the achievements and challenges he and the legislature have faced during his three terms as Governor. In his remarks, the Governor talked about the Climate Commitment Act (CCA), and in doing so, he included how the Act is benefiting coastal communities that are facing impacts from the rising oceans.

The Governor said, "We are glad that today we are joined by Vanessa

Kowoosh from Oueets. Vanessa works for the Quinault tribe's Generations Building supporting the community's culture through history and language and early education programs. Community resources like these are threatened because the very land it's on is at risk because of sea level rise caused by climate change. They are not the only coastal communities living with this threat, the climate commitment act is supporting them by charging polluters and investing in those communities' relocation

to higher ground. Thanks to the climate commitment act and the choice by lawmakers to honor its purpose, the people of Queets are getting a new Generations Building on higher ground, safe from flooding, funded by Cap and Invest. It's just one example of so many of how CCA is keeping our communities to be safer and healthier. Vanessa, we wish you well, we are going to keep you high and dry. So, Vanessa, thank you for being

# West Coast Ocean Tribal Caucus - 2025 Tribal Summit

On January 13 - January 15, 2025, Tribal representatives from the Westcoast of

the U.S. met at the Quinault Beach Resort and Casino to honor Tribes' Rights in the

protection and planning areas. The Summit provided a platform for inter-Tribal sharing of successes and challenges that would be informative to others to learn from.

On the first day, the tribal representatives visited Taholah to get a tour and hear from Councilmember Hendricks, staff Lia Frenchman, Justine James, Joe Schumacker and others about how the change in the climate is affecting our coastline, resources and the plans for relocating the lower village to the Northeast Neigh-

Ocean, with a specific emphaborhood to escape the rising forts to implement a co-manocean. The group was also treated to an opportunity to dig razor clams on the beach directly in front of the Quinault Beach Resort & Casino.

> Throughout the Tribal Summit, were panels of representatives to cover topics such as challenges in accessing the resources, impact on resources such as fur seals from commercial fisheries in the Berring Sea with Alaska Natives, and discussions about protective measures and assistance from options like the creation of a Sanctuary approach. In other examples presented where ef-

agement agreement to benefit or protect resources, but in some cases, they were not successful due to the lack of response or cooperation from the federal agency involved. Each speaker expressed the difficulty in working with outside agencies, states and in some cases, their own tribal council to get agreements created and implemented. In many cases when agreements were developed and implemented, the response by the non-tribal public was a bit fearful of how



# **Leonard Peltier is Going Home:** A Step Toward Healing and Justice

Washington, D.C. | The National Congress of American Indians (NCAI) celebrates the historic decision to grant clemency to Leonard Peltier, an 80-year-old elder of the Turtle Mountain Band of Chippewa, federal boarding school survivor, and one of the longest incarcerated Native American political prisoners. In his final moments in office, President Biden commuted Leonard Peltier's two life sentences, allowing him to serve the remainder of his sentence from home. While this decision does not exonerate Leonard Peltier for the crimes of which he was unjustly convicted, nor does it erase the decades of suffering and profound injustice he endured, it offers him the opportunity to return to his ancestral homelands and spend his remaining years with his  $loved\ ones\ -\ a\ long\mbox{-overdue}$ step towards justice that will allow collective healing for Leonard Peltier and the broader community. Upon learning about President Biden's historic action, NCAI President Mark Macarro stated, "After nearly 50 years of unjust imprisonment, President Biden's decision to grant Leonard Peltier the opportunity to return home is a powerful act of compassion and an important step toward healing."

As we celebrate Leonard Peltier's commutation, it is important to recognize that Leonard Peltier's case has long symbolized the systemic injustices faced by Indigenous Peoples. This victory belongs to those who have fought for justice, especially those who refused to let the injustice against Leonard Peltier fade from public consciousness. This moment serves as a testament to the power of tireless advocacy, grassroots organizing, and intergenerational collective action by Tribal Nations, human rights organizations, and global allies.





She traveled with her friend Mary to Alaska and Hawaii which were some of her highlights for travel-



ing. Cindy never spoke any unkind words towards anyone and would instead pray for everyone. She was an aunt and spiritual mother to many.

Cindy was the oldest of her siblings and the only girl with three younger brothers. She was known for and enjoyed helping get her brothers in line as they were growing up. She carried this on with her nephews and nieces, always encouraging them to go to church and praying with and for each of

Cindy was a proud, active member of the Chinook and Quinault tribes. She enjoyed picking blackberries growing up which many cousins can provide fun stories about. She shook crab at Harbor Bell, and thoroughly enjoyed digging razor clams with her family members on the Washington coastal beaches as well as on the

Willapa Spits. She could out dig many men who were half her age! Cindy also commercially fished with her dad David (Bug) Frank and brothers on the Chehalis River, Palix River and Willapa River.

Cindy also did a LOT of driving for her family members and for clients in and around the areas where she resided. She loved helping people, so this was one of the many great ways she was able to do that.

Cindy is survived by her siblings Herb Frank and Steven Frank; her nephew's Derick Frank, Kyle Frank, and Chris Frank; her niece's Angie Frank, Stacy Anderson-Frank, Samantha Eller (Frank), Stephanie Terrell (Frank), and Amanda Frank. Cindy is also survived by many great nephews and nieces as well as many cous-

Mike was born in Aberdeen on May 6, 1960, to Blanche (Wells) and Samuel Miller Sr. He was descended from Quinault and Skokomish and a Nisqually tribal member. His stepfather Charles Lane was a constant in his life, as were his Aunt Angelic and Uncle Francis Napoleon Jr. Along with his siblings Sam, Charles, DeAnn and Joni, Mike spent his childhood in Grays Harbor. He graduated from Weatherwax High School in 1978.

In 1979 he married high school sweetheart and soul mate Kelly Fisk. They had two children, Ryan and Katie. They made their home in Central Park and Mike worked for Industrial Electric in Aberdeen. He was a Quinault treaty fisherman, spending many salmon runs on the Chehalis River with his cousin Francis Napoleon III. He took great joy in



fatherhood and could always be found at Cub Scouts, 4-H, school and sporting events around town.

After the children graduated Mike took a job with the Quinault Tribe opening the Ocean Shores market and eventually managing the Taholah Mercantile. He and Kelly enjoyed traveling. They celebrated their 25th wedding anniversary in Maui and later travelled around Europe. He also made many trips to California to visit Katie and cheer on his future son-in-law Tim. In 2008, Ryan married Mellanie and in 2009, Katie married Tim; Mike loved them like his own.





### RETAIL OPERATIONS

Submitted by Retail Managers

- Amanda Park Fuel sales for FY23 were 174 gallon. short of FY 24. Last year we based our fuel prices off Q2, but this fiscal year we base the cost of fuel and add our margins on all fuel sales
- Amanda Park is working to replace the generator as clients travel elsewhere when our site is down during power outages. The power went out four times in the past months, with one outage lasting over 28 hours resulting in a full day of zero sales.
- Total sales at Amanda Park for the current period are down \$13,000 compared to FY23 primarily due to seasonal traffic along the coastal highway.
- Maintenance staff at Amanda Park are working on leaning pumps, pressure washing the fuel canopy and maintaining the fuel station.
- QMart I Ocean Shores carton sales for the month were 3,059, which is down by 227 cartons compared to 2023 and down by 941 cartons compared to the benchmark of 4,000 cartons per month.
- QMart I overall sales are down by 1% compared the budget, resulting in a decrease of (\$2,779) for the month of 2024 compared to budget, and below 2023 by (\$405).
- On November 20th, QMart management participated in a TCSA webinar for Interpersonal Skills for Managers, which provided valuable information.
- QMart II Aberdeen began offering great deals on slow-moving liquor/wine items. Sales for liquor/wine reached \$131,570, up 6% from last month.
- QMart II fuel volume sold was 305,677 gallons for the month, 7% over monthly budget.
- QMart II had an issue with the combination of a "king tide" and heavy rain which caused flooding in the Aberdeen area. As a result of the flooding our Premium fuel tank had an intrusion of water. At the first notice of the possible issue, the complete fuel island was shut down. A total of 19 vehicles have filed claims with damage to their vehicles with water in the fuel. Management is working with USI/Tribal First on each claim.
- QMart II is getting a quote to upgrade our Veeder root to a TLS-450 console with upgraded operating software/ printer. Our original console has been continually tripping and shutting the pumps down.
- QMart III Bremerton general Merchandise-Carbonated drinks didn't meet the number of 9,500 due to lack of inventory. An increase in delivery would boost our number of 6822.83 to its expected mark.
- This month QMart III generated \$109,830.25 in OTP sales; cigarette sales went down to 8,674 cartons to an average of 289 cartons a day due to the seasonal drop in sales.
- QMart III has new competition with a new Suquamish smoke shop opening on Kitsap Way, which is about six blocks away from our operations.
- Gross Profit for Tribal Cigarettes is at 52.90%, which continues to be a major selling product for QMart III.

- A work order for maintenance to put lights in our storage crates was submitted and completed by QNEB Facilities. This will help our staff feel safe when getting product/inventory form storage during non-daylight hours of operation.
- Queets Trading Post orders from different vendors for groceries that include Walmart, Amazon, Swanson's, and our main distributor Harbor Wholesale.
- Monthly staff meetings are very beneficial to the staff as well as the manager, being able to handle issues daily has been my main concern.
- Queets Trading Post total fuel sales compared from FY23 to FY24 are up over 5,700 gallons, last year we did not have fuel sales for diesel. Regular was up 3,300 gallons this year from FY23.
- Overall, with FY23 year compared to FY24 year are up \$15,000 with the different vendors we continue to order from and keeping the store stock and full to the customers has helped with this increase, in house charges continue to be steady, and ensuring were ordering accordingly.
- Queets Trading Post budget shows a loss of (11,154) but will be about (7,000) loss after they fix the credits that need to be adjusted in budget.
- Taholah Mercantile experienced storms that knocked out power, but we were pro-active enough to prepare for those days. We implemented a new safety precaution since we are still without a generator. On upcoming storm days, operations keep the freezer inventory low, leaving small amounts of frozen inventory stocked just in case we lose power. This inventory is replaced as soon as possible with inventory purchase runs to Aberdeen.
- Taholah Mercantile celebrated Edward Comenout for 10 years of employment with
- customers.

   The new front door was in-
- stalled.
  QNEB Facilities continues to work to fully repair the generator and will have a leased generator onsite during the winter months for emergencies if the store generator does not start up.
- Taholah Mercantile is advertising open positions and cashiers to ensure operations are fully staffed over the weekend.

### SEAFOOD OPERATION

- Submitted by General Managers
- Quinault Pride Seafood was a relatively quiet November, marked by steady operations and no significant events. The team continued to focus on meeting production targets and maintaining smooth workflows throughout the month.
- Collaboration with Pacific Harvest Seafood continues to highlight the strength of our working relationship. Together, we have made significant progress in moving fresh and frozen inventory efficiently, ensuring a minimal inventory balance is maintained.
- A considerable amount of time and effort was dedicated this month to collecting and analyzing data for the presentation "Quinault Pride's Sustainability," which will be delivered at this board meeting. This presentation reflects our commitment to transparency, sustainable practices,

- and the long-term vision of Quinault Pride Seafood. The process of compiling this information has deepened our understanding of our operational impact and reinforced the importance of sustainability in everything we do. Additionally, positive efforts with Pacific Harvest Seafood continue to yield excellent results, as we effectively move inventory to maintain balance and meet market demands. This partnership underscores our shared commitment to efficiency and mutual success.
- Tribal vessels for QPS/JR departed on December 29<sup>th</sup> for the beginning of the crab season. Vessels began delivering to QPS/JR on December 30<sup>th</sup>/January 1<sup>st</sup>. Fishermen came in with good loads of quality crab with cooperating weather conditions.
- Jolly Roger Seafood purchased new totes and has finished putting the parts together to make live totes with them.
- Jolly Roger Seafood had a HACCP Audit and passed and had no findings. JR also had a department of Ecology inspection and passed this as well with no findings.
- All forklifts and other equipment were serviced and believe we should order a new one once the state crab season has started. This was approved for the 2025 FY budget plan.
- Prior to the crab season, JR purchased 80,000 lbs. of squid for the upcoming crab season and has this in our freezers on site. The JR team completed minor repairs on the icehouse and other preventive maintenance to prepare for the crab season. This included having our crane refurbished and fully repaired.

### **QUINAULT LAND AND TIMBER**– Submitted by General Manager

- Submitted by General Manager There have been no material changes to the log market from the previous past months (summarized below). Demand for logs of all sorts and grades is beginning to trend upward; however, log prices still have not seen considerable changes.

- Plywood Veneer and peeler log prices are beginning to trend upward. Demand for Western Hemlock peeler logs is increasing at Pac Veneer. Western Red Cedar sawlog prices are seeing the typical seasonal low.
- Pulp and Chip 'N Saw demand and pricing remains steady as Willis Moon Island continues to barge chips to Vancouver BC. Reports of Cosmo Fiber reopening during second Quarter of FY2025 could have considerable positive impacts on log pricing and demand.
- Reservation timber sale volume has been below QIN AAC objectives for at least the last 18 months. Recent discussions with QIN Forestry staff suggest that Reservation volume will be lower than expected for the second straight year. This puts enormous pressure on QLTE to expedite its own sale schedule. Inefficiencies in the presale process for timber sale reviews and approvals are the primary cause of low QP timber inventory.
- QLTE continues to increase cedar salvage sale activity on QIN lands following QBC approval. Although QLTE revenue from cedar salvage activity is expected to be minimal, QLTE is focusing on increasing its capacity to administer sale activities outside of QP involvement. QLTE is also committed to generating much higher than historical cedar salvage stumpage values on QIN lands. In the long term, QLTE could develop a program aimed at investing in trust allotments specifically for cedar salvage revenue potential.
- A P&SA was signed for the acquisition of 160 acres of reservation Fee land. This transaction is expected to close in January of 2025. The

160 non-contiguous block of reservation land has some near-term timber and salvage value that can recouped.

# QUINAULT CORPORATE ENTERPRISES Submitted by Executive Management

- COO held a meeting with Circle Seafood and GH Historical Seaport to discuss the proposed operation of unloading frozen salmon. This would be material to Quinault Pride Seafood and operations will need to ensure it does not affect Quinault Tribal fishing rights on the Chehalis River.
- COO and QBRC Executive team are working with Lamar for the removal of the sign behind QMart I Ocean Shores location. The sign is over 25 years old and is no longer accessible and has been deemed a hazardous structure. It will need to be removed by Larmar in January 2025.
- Working with QNEB legal, we have finalized the process to dissolve Quinault Solutions and close operations. The company Quinault Solutions has not shown any revenue in over three years and needs to be administratively closed.
- Transition to Cougar Den is being reviewed by QIN AG office with the recommendation to enact new codes within the fuel compact and have it approved by General Assembly.
- Due process is being completed for two grant applications with Washington State PLIA (Pollution Liability Insurance Association) to replace the aging tanks at both Amanda Park and Taholah Mercantile.
- QMart I management with COO are with Clarke Signs to replace the sign at the "T" at Hogans Corner for QMart Ocean Shores.
- Central Accounting has started the analysis of QNEB Spend, Facilities Spend and HR Spend into a reviewable budgeted format.
- The Central Accounting Team has been working directly with Moss Adams to complete and finalize the QNEB audit.
- Central Accounting is also working in conjunction with Quinault Pride Seafood internal accounting staff to implement Meritech, a cost accounting and inventory software program to improve inventory management and controls.
- Tony Enzler (QNEB COO) and David Martin (QNEB CEO) now have offices at the QWC Annex building on Park St. in Aberdeen.

New programs and treatments have been introduced to address the evolving


needs of the community, including specialized care for chronic conditions and enhanced mental health resources.

# Plans for QIN Public Safety's new Correction Facility Mark James - Public Safety Director




In 2018, Public Safety began discussions with the BIA to move forward with the building of a new jail facility for Quinault. After much communication and back and forth to repair the facility, the BIA recognized the current facility to be woefully in need of constant repair and that it carried a high liability located in the Tsunami zone. In FY21, the BIA finally started moving forward to design and build of a new facility. The BIA entered into an agreement with the Quinault Nation to relocate and build a new jail facility.

In 2022, Lt. Ron Belcher and I began meeting with the BIA on the scope and search for a location of the new facility. After looking at several areas, the Nation settled on a location located on the South side of KLAOOKWA Avenue across from the Roger Saux Health Center. This area fulfilled the needs of building the facility as well as the various operational needs of the jail. Fast forward to late FY23 and many planning meetings, the BIA selected Godberg Architects to design and build the new jail facility. Lt. Belcher and I attended bi-weekly meetings with the Architect, BIA, Department of Justice, and

other associates throughout the FY23 and FY24 years to develop and produce a 100% design of the new facility.

Many things were considered during this phase such as size of the facility, designing in such a way to fit aesthetically in the community, security, modernization and ease of operation. It was a monumental task that pitted concerns of the operational and security aspects of the new facility with a design that enhances and augments the look and feel of the building to fit with the QIN culture.

On one hand, the BIA promoted a style of jail they had successfully built on other reservations to utilize plans they were comfortable with, but on the other hand, we wanted a facility that honored Quinault and provided not only the security, operational efficiencies, safety and respect of our inmates, but an aesthetic design that fits in our community. This mandate went forward to the architect who went to work and came up with a great design which after much tweaking, was finalized at the end of FY24. This design allows for all the necessary safety, security and operational needs while meeting the traditional

### **Current Projects include the following:**

### **Quinault Court Replacement**

- New Court House in the Relocation Area is moving into the planning phase
- Environmental work has been completed
- Finalizing securing of funding, after the tragic loss of the court trailer

### Taholah relocation water system improvement

- Engineering has been completed, and the project is in the constructions phase
- Funding from Commerce, Ecology and IHS are being combined to fund the project
- The three 158,000-gallon tanks will supply water volume and pressure to homes and services in the relocation. Without this step, homes in the relocation would not have adequate water

### **Photo Voltaic Energy Park**

- QIN received a total of \$7.4 million from the Tribal Electrification Program to build 2 MW solar park for homes in the Taholah Relocation
- The energy park is adjacent to the water tanks, and will provide power to homes and the relocation moving QIN towards energy sovereignty

### **Queets Generations Building**

- Will house the Senior Program, Head start, and Daycare
- The 10,000 square foot building will offer emergency shelter in the event of disaster
- The building is scheduled to be fully operational this fall

### Taholah Relocation

- QIN was awarded funding through the BIA Tribal Climate Resilience funding to move forward with Phase
- This funding will cover lots for additional housing, including apartments, road plans to support the housing and school, locations for civic buildings as well as plans for all needed infrastructure

### Museum

- The QIN Business Committee appointed the area south of Kla Ook Wa Drive and east of Kwela Drive as the Cultural Designated Site
- Design is underway for the Museum/Cultural Center and Education Center

### Taholah School

- The QIN Business Committee approved a new lease for the new Taholah School location for 35 acres in the upper village.
- The design process is underway for the new school and associated program facilities
- The school district is anticipating starting construction in fall of 2025, and anticipates open for school year 2027/2028

### **Taholah Generation Solar Panels**

- Elemental Energy is finalizing plans for the roof mounted solar panels
- QIN received funding to training tribal members in solar installation

### **Queets Relocation**

- Queets Master Plan completed by Red Plains Professions with significant community outreach. Plan was completed by Kelsey Moldenke, previously Senior Planner with QIN
- Engineering for Queets relocation Phase 1 began in January and will be completed by June 2025. The end goal, with geotechnical and environmental compliance completed, is a shovel ready project with lots for 23-25 new housed
- Earmark for funds to clear Allotment 100 approved by governor's budget and should be formalized in the June 2025 budget

### **Detention Center**

- The design for the new Detention center was completed in 2024
- Construction is slated to begin in May 2025 (see facing page).

Dear Legal Aid Abby:

My in-laws, who are non-native, have just filed to have a court order so they have time with my child. There's a question on the court form asking if my child is an Indian child. Why is the court asking this, and how should I respond?

Dear Concerned Parent,

I imagine this is a stressful time for you and your family. The court form asks about your child's Indian status because there are protections for American Indian children to stop the historic and ongoing removal of Indian children. These protections are contained in the Federal Indian Child Welfare Act (ICWA) and the Washington Indian Child Welfare Act (WICWA)

One requirement is providing notice

to the tribe (or tribes). The tribe defines whether a child is a member. The tribe can join the case or request it be moved to tribal court.

If you have reason to believe your child has any native heritage, you should answer "yes" to this question. It is your relative's responsibility to contact the tribe(s). You can also contact your tribal ICWA or enrollment person.

Additional ICWA and WICWA safeguards include providing you with a free attorney, engaging in "active

efforts," and, in the case of de facto parentage cases, a dismissal because it is inconsistent with the definition of a parent under ICWA.




### 1st grade Jada Juneau







# Lillian "Jo" Luscier Brown

Every elder interview that we do is amazing, and this one with Lillian "Jo" Luscier Brown is no exception. Lillian expressed her love for her children and grandchildren, how awesome they are and what care they provide her with. She says always be good to them, they are the ones that take care of you later in life.

As we did this interview, probably one of the most surprising things that she shared with us was her love of baseball. She sponsored her own team for many years, spoke highly of all that played on her team. She even turned down going to an Elvis Presley concert because there was a baseball game that she didn't want to miss.

Her parents, Antonne and Christine raised five kids, Lillian said throughout her life she lived in a variety of towns, ranging from the Taholah to Queets areas, including Neilton and Bay Center. Besides loving baseball, she loved swimming. She shared one of her funny stories about swimming, she remembers being thrown off the fish house dock by Skeeter Underwood. Any person that went swimming down at the docks usually ended up being thrown off the dock. Often kids that swam in the Quinault River always tried to swim across the river, and down by the mouth where the water was always swift. But her favorite swimming location was Lake Quinault. She said that once you jumped in the Lake, it didn't take long to get used to the cold water.

Most of our elders will remember Judy Millett, who was one of her sisters (Pearl said she certainly remembers Judy, her sense of humor, her smile and her being a strong clam digger). Lillian herself was an avid clam digger. Her family often canned clams, elk, deer, fish and all kinds of fruit. She thought that when you canned food, it all took the same amount of time (cooking and processing them) but quickly learned that you don't need to cook peaches and can them in the same amount of time as other foods. She loves all tra-

ditional foods, and will never turn down a fish, especially a Blueback.

Lillian worked for the U.S. Government for many years, predominantly the BIA where she worked with Kay Filyaw, Ray Strong, and Madonna Renville.

She had many fond memories of growing up, but one in particular was when she was a very little girl, the family was living in the Clearwater area. It was close to Christmas time and her mom kept telling them that since they recently moved to that area, Santa Claus probably would not be able to find them (her mom didn't tell her that they didn't have money to

buy gifts). But she remembers that on Christmas Day, here comes several ladies from the village of Queets bearing gifts, dolls for the girls and trucks for the boys. She said it was like magic, getting a new doll. Today she believes that the Tribal members from Queets are the most kind, friendly and generous people, plus being great cooks. She recalls that Janice Charley and Dar Snell were two childhood friends that she enjoyed hanging out with. She was very blessed in the respect that most of the houses she was raised in had running water and electricity.

She said she loves to go to garage sales, rummage sales, estate sales and bazaars. Her kids at times have to remind her that she doesn't need to buy everything, or she'll end up living like a hoarder. Her family is very religious, and always attended the Pentecostal church. She believes that everyone should have faith in the Lord. Lillian did travel, when her daughter Lorinda was serving in the military, wherever she was stationed, she would fly there to visit.

Lillian said she does have reservations about the proposed changes to the Constitution, which would allow a tribal member to serve on the Council if they don't reside on the reservation. She believes that Council members should reside on the reservation.

Lillian shared many funny moments about the various dogs that she owned. We found out that she is an avid collector of Snoopy items, even her Christmas tree has a snoopy that serves as a star on her tree. She says that you are never too old to learn new skills and would like to attend the Quinault Language classes and is very interested in learning how to make baskets. She thinks we should live our life to the fullest with faith in God, and to be kind to people. And last, but not least, she loves KFC and always has her kids stop and buy chicken, after a quick run to Walmart.

# Gerald "Juke" Ellis


Recently the Conversion Center staff interviewed Gerald "Juke" Ellis. Every elder interview that we have done is interesting and unique, and Juke was no exception. He is 80 years old and has lived what most people would consider a fascinating life, sometimes he followed the rules and sometimes he made his own decisions and rules.

His grandfather was Johnson George, and his grandmother was Elizabeth Charley (Nina Bumgarner's sister). He recalls being in his grandfather's ocean fishing boat from the time he was extremely young, people used to say that you could see

his diapers hanging in the mast when he was on the boat. He fished on the ocean boats probably until he reached the age of 21, enjoyed fishing from the Columbia River to Vancouver Island, and that's when you just had to have a blue card! Of course this was pre-Boldt. He recalls Horton Capoeman always telling him that it's bad when we must go to court over our rights, we need to do it, but often lose.

Juke also was out in the woods with family making a living cutting shakes and going into the mill business for shakes and shingles. He expressed frustration with the BIA process of obtaining permits and was always disagreeing with Mike Kupka. Juke was one the Quinault members that fished on the Chehalis River post Boldt era and didn't experience getting shot at, but had plenty of washers, dryers, bicycles, etc. in his fishing net. His education was limited, he went to school until the 8th grade in Taholah but had a Master in BS that continued to be useful during his years of serving on the QBC, often used his BS when visiting with politicians.

Our interview with Juke would fluctuate from the current years to his younger years. His biggest accomplishment thus far is living to be 80 years old, was married to the love of his life Emma, they raised five children, sadly some of his children have passed on. It was tough for him having to take care of the ones that passed on, parents are not supposed to live beyond their children. But he has 15 grandchildren and 37 great grandchildren and still counting. He fondly remembers his mother Geraldine being one of the greatest cooks in the village, anyone who needed a meal knew they would have a hot meal if they went to her home, she never turned anyone away. Sturgeon was one the best fish that she cooked, (Pearl mentioned that her brother Amo apparently loved her sturgeon dinner so much that every time their father threw a sturgeon away, he (Amo) would grab it and take it to Geraldine to cook). Juke learned to cook just about anything from his mom, including fry bread, buckskin bread, raised yeast bread. He still loves to cook traditional foods like clams, elk, bear, beaver, and enjoyed snipe soup, duck soup, fish soup and eating geese (but it has been a long time since he had a goose).



Growing up some of his best friends were the Simmon's boys. Kids used to play kick the can, hide and seek and a lot of football. Kids today pay too much attention to high technology stuff; they don't have respect for the rights that we have enjoyed for years. He served on the Council for many years but had a lot of frustration with some of the advice of non-tribal staff to the Council, but appreciated Dan Raas, who was one of the Tribal Attorneys. Juke recalls fighting with Guy "Butch" McMinds verbally over many issues, one issue was hunting. He strongly suggested to former Chairman DeLaCruz and Councilman McMinds that they shoot an elk in the Bay Center area to make a statement about Quinault hunting rights, but they chose not to accept his advice.

Juke grew up in a time when there was no running water or electricity in the home but was very grateful when John Doe (Vernon Shipman) had running water put in their house. Was very proud that they had a two-seater outhouse (that was high tech — Juke's words). He fondly recalls cutting kindling for many of the elder ladies here who could probably put many men to shame with their strength and skills, Gram Sarah Sotomish could always carry heavy loads of driftwood on her back with her basket.

Most tribal members know that when there are a lot of eagles flying around that Juke has been feeding them, he loves to feed the eagles fish or seals that have washed up on the beach. His words of wisdom to Council members is to Think Indian. And as far as moving the village to higher ground, he asks that they remember that all members who may want to move to higher ground, just can't afford to pick up their home and move, they don't have the necessary resources.

Buying back land has been on the Nation's great accomplishment, but there are still many small interests of land that can be purchased.

We had a lengthy interview with Juke, this article reflects the highlights. Additionally, Juke spoke highly of Kurtis Cheney, he said that he would always be willing to bend over backward to help tribal members in his job, and there a lot of people who miss working with Kurtis.

We gave Juke some Indian Tea that we hope he will enjoy.



### Ongoing river erosion continues to threaten roads in the Quinault Valley above Lake Quinault



The Quinault River experienced a high flow throughout the month of December with a section of the river directly hitting the bank and creating a whirlpool effect that eroded the South Shore Road around mile 10. This area, located less than half a mile upstream from QIN's Alder River Rehabilitation site in Jefferson County, has been plagued with washout issues for decades. The road was relocated further from the river several years ago, but ongoing erosion is once again threatening the road. The road was closed before the end 2024 at the Grays Harbor/Jefferson County line. # Fish War



On January 17 many of the QIN staff attended the showing of FISH WAR in the afternoon at the 7th Street Theater in Hoquiam. There was also and early evening showing of the film for the general public.

When the state of Washington made it illegal for tribes to fish for salmon in their usual and accustomed places, it was a declaration of war. FISH WAR follows the tribes' fight to exercise their treaty-reserved fishing rights. A landmark court case in 1974 would affirm the tribes' treaty rights and establish them as co-managers of the resource, but the fate of salmon in the Pacific Northwest still hangs in the balance.



agreements like Sanctuary protections would affect them. It was mentioned that explaining and meeting with neighboring communities or governments, is a strategy that can build support for more successful outcomes in managing ocean resources for whatever strategy is being proposed or implemented.

Marine Climate Impacts for Planning and Resource Management was another topic of discussion. The Shoalwater Bay Tribe talked about toxic algae blooms and how they are making their way into the Bay due to the higher temperatures in the waters. The impact on the farming of oysters is devastating and deadly. By sharing experiences of what is working or what solutions or strategies are being used, can help others avoid pitfalls or unnecessary steps.

Collaborations in funding to address these issues was an important topic due to the costs and man hours to study them, work on them, and staffing them, otherwise it may not be feasible or affordable. As we are experiencing at Quinault, with the flooding, relocation, erosion, and the funds to address all of these comes with a big price tag and many years to develop and complete. And that's in addition to the other impacts to our ocean and river fisheries and other resources.

The last day of the fourday gathering included Federal, state, tribal and two federal sister agencies – Bureau of Ocean Energy Management (BOEM) and Bureau of Safety and Environmental Enforcement (BSEE) for offshore energy, oil, gas, wind and tidal issues. The day was used for interactive group discussion on priorities and goals for the final two years of NOAA Regional Ocean Partnership funding. In the final session, the Summit concluded with a recap of themes, takeaways, and meeting to address follow-up tasks identified over the week-long gathering.

### Air Quality News

Happy 2025 from Quinault's Air Quality Program to all readers! We're excited to share the program's recent achievements for the health of your air. Firstly— great news for Quinault Elders living within 25 miles of Taholah or Queets, who use a woodstove for heat! Free dry firewood shares are now available for you. In collaboration with the Senior's program, a firewood storage shed has been constructed for both villages. To request your share, call Quinault extension 7419 or 7415; or email <a href="mailto:seniors@quinault.org">seniors@quinault.org</a>. How does this improve air quality? Dry, seasoned firewood burns approximately four times cleaner than wet wood. Woodsmoke, especially in high concentrations, is harmful to the human respiratory system, and prolonged exposure can affect other systems of the body. These can include the cardiovascular, immune, and reproductive systems. Less woodsmoke = healthier air in your home and the local atmosphere!

We are also excited to share our recent application to the Diesel Emissions Reduction Program; this proposal is supporting Quinault's fishing fleet vessel *The Kraken*. This EPA grant funds emissions-reducing upgrades for awardees' diesel vehicles. Diesel emissions are highly carcinogenic, and of course harmful for the environment. So, fingers crossed for *The Kraken*'s application and its Quinault owner!

Lastly, if you are a QIN employee and have an air purifier in your office needing filter replacement, filters will be replaced by March. Budget challenges and missing deliveries delayed things a little, our apologies!

### BYLAWS of the Quinault Business Committee of the Quinault Indian Nation

Revised November 12, 2024

### **PREAMBLE**

We, the Quinault Business Committee, the governing body of the Quinault Indian Nation, having been entrusted by our people, through the Constitution, to pursue our right of self-determination and self- sufficiency; to protect, develop, enhance, and preserve our human and natural resources, our culture, and our identity; and to exercise our sovereign powers over all land, resources, and people within our jurisdiction, do hereby approve and adopt these By-Laws according to Article IV, Section 9, of the Constitution of the Quinault Indian Nation.

#### **ARTICLE I - OFFICERS**

The Officers of the Quinault Business Committee shall consist of the President, the Vice- President, the Secretary, the Treasurer, and seven (7) Councilpersons for total of (11) Officers. The said eleven (11) Officers shall have the right to vote on issues brought before the Quinault Business Committee.

### **ARTICLE II - POWERS**

The Quinault Business Committee shall exercise all powers granted to them pursuant to Articles V, Section 1, 2, and 3 of the Constitution of the Quinault Indian Nation.

### **ARTICLE III - RESERVED POWERS**

Unless approved and enacted by Resolution, Law, Ordinance or By-Laws, the Quinault Business Committee reserves to itself all and every right, power, and authority, express or implied, delegated to it by the Constitution of the Quinault Indian Nation.

### **ARTICLE IV - MEETINGS**

Quinault Business Committee meetings shall be open to the public unless expressly stated otherwise in this document. A schedule of Business Committee meetings and subcommittee meetings shall be published yearly.

### Art. IV - Section 1. Annual Organizational Meeting

The Quinault Business Committee will meet within forty-five (45) days after the Annual Meeting of the Quinault Indian Nation General Council in order to:

- Discuss resolutions and general session items of the Quinault Indian Nation General Council;
- Schedule an orientation for newly-elected Officers to the Quinault Business Commit-
- X. Establish and reorganize committees;
- Review and evaluate Quinault Indian National goals, organizational objectives and tribal programs;
- Re-direct efforts found to be inconsistent with the wishes of the Quinault Indian Nation General Council;
- Review the effectiveness and direction of the administrative organization;
- Appoint Officers to chair specific committees:
- Identify and address any other Quinault Business Committee organizational tasks.

### Art. IV - Section 2. Regular Meetings

Regular meetings of the Quinault Business Committee will be held on the second (2<sup>nd</sup>) and fourth (4th) Monday of each month at a location within the Quinault Indian Reservation as designated by the Quinault Business Committee, unless there is a situation requiring that the meeting be cancelled or rescheduled, upon consensus of the Business Committee. Regular meetings vill be convened at 5:30 p.m., except when the Quinault Business Committee, in its discretion, sets them at a different time. At least one meeting a quarter will be scheduled in Queets

When the regular meeting date falls on a holiday recognized by the Quinault Indian Nation, the meeting will be held on the following business day. A day other than the business day following the holiday may be chosen by majority consent of the Quinault Business Committee.

### Art. IV - Section 3. Special Meetings

Special Meetings of the Quinault Business Committee may be held at any time or place within the boundaries of the Quinault Indian Reservation. Special meetings may be called by the President or the Vice-President. Notice shall be given to the public three (3) days in advance but may be held on shorter notice with majority consent of all Quinault Business Committee Officers. The notice shall be posted in the usual public places by the Secretary and corrected if the time or place of the meeting changes. In order for the Officers to address the issue or issues before them, the person or persons calling the meeting must present all pertinent facts, material, and information to those Officers attending.

### Art. IV - Section 4. Emergency Meetings

Emergency Meetings of the Quinault Business Committee may be held at any time and any place within the boundaries of the Quinault Indian Reservation. Emergency meetings may be called with electronic notice by the President or the Vice- President. Every effort shall be made to contact all members to give notice of the meeting. The Officer who called the emergency meeting must present all pertinent facts, material, and information regarding the issue or issues to be addressed to each Officer present. A quorum of the Quinault Business Committee Officers shall be established in order for any action to be binding. Emergency meetings of the Quinault Business Committee may be held by means of conference telephone or similar communications equipment if the call or meeting is originating from the Quinault Indian Reservation. A minimum of six Officers (a quorum) must be present within the boundaries of the Reservation in order to conduct business. Once the in-person quorum requirement is met, other Officers may participate and vote by telephone or virtual platform.

### Art. IV - Section 5. Legal Session

The Quinault Business Committee may hold a Legal Session to become informed and updated

on current legal issues that have or may have an impact on the Quinault Indian Nation. The Legal Session is an information-only session that will be closed to the public due to sensitive legal issues that may arise. Only those persons whom the Business Committee approves to attend the Legal Session may be present. All information, including discussion and documents, presented at the Legal Session is privileged and confidential and shall not be disclosed or made public unless the Business Committee determines otherwise. Any formal decisions on legal issues shall be addressed in a regular meeting of the Quinault Business Committee.

#### Art. IV - Section 6. Executive Session

From time to time issues of a sensitive nature will come before the Quinault Business Committee. These issues shall not be discussed publicly unless the Business Committee determines otherwise. To address sensitive issues, the Quinault Business Committee will conduct an Executive Session. Such issues will be set apart from the regular agenda for discussion in an Executive Session. Only those persons whom the Quinault Business Committee names will be present in the Executive Session.

Issues that shall be discussed in Executive Session, unless the majority of the Business Committee decides otherwise, include but are not limited to:

- A. Personnel that the Business Committee has purview over
- B. Minors and the protection of minors, or victims and potential victims of crime
- Confidential or proprietary Quinault Business or Enterprise matters
- D. Matters that require confidentiality under Federal, State, or Quinault law or policy
- E. Matters that require confidentiality under any agreement or contract entered into by the Quinault Indian Nation
- F. When requested by a Tribal member, but only if it is clear what topic the Tribal member wishes to discuss and the administrative process has already been followed, except the Business Committee will not entertain personnel issues or issues related to active court cases.

### Art. IV - Section 7. Business Committee Agenda

- A. <u>Submitting Agenda Items</u>. The agenda for each Quinault Business Committee meeting will be prepared by the Secretary and posted each Friday prior to the regularly scheduled meeting. All agenda items shall
  - Submitted to the Secretary no later than 4:30 p.m. on the Wednesday prior to each regular meeting;
  - Submitted in writing and in the form prescribed by the Secretary and/or through the online portal designated for governmental meeting agendas; blank/incomplete agenda requests will not be accepted; and
  - Items submitted for the agenda shall include:
    - a. an attached resolution if necessarv
    - b. a clean version of final document an agenda request approved by
  - the designated approver. Assembled and available at the Quinault Indian Nation administrative complex to each member of the Quinault Business Committee on the
  - Friday prior to each regular meeting. Whenever possible, agenda items should be vetted through the appropriate Subcommittee or Committee, Commission, or Board before submission to the Business Committee
  - agenda. The Secretary reserves the right not to accept agenda items that do not meet these requirements.
  - To address privacy and confidentiality concerns, the public agenda packets will only contain copies of the resolutions being presented.

### B. Added Items.

- Generally, the Business Committee will not add items to the agenda at the meeting.
- However, there may be times when an item will need to be added. Any request to add such an item to the Agenda including the Executive Session must be stated before the vote to approve agenda with added items.
- The Chair will ask if there are any objections to the added items. If there are any objections, each added item will be voted on separately, and a 2/3 majority of the members present will be necessary to add the item. If there are no objections, all added items may be voted on with one vote.
- Any added items shall have supporting documentation and include the action requested.
- C. Elders Agenda Items. Elders 55 years or older who have properly submitted an agenda item and are presenting it at the meeting will be moved to the top of the
- D. Rejected or Tabled Agenda Items. The Quinault Business Committee may reject or table any agenda item for one or more of the following reasons.
  - The material and information relating to the agenda item is incomplete;
  - 2. The material and information relating to the agenda item has not been reviewed by the appropriate Division or department staff, CCB, and/or Subcommittee;
  - The person who presents the agenda item is not present; The agenda item is an issue which can
  - be decided outside the Quinault Business Committee;
  - The resolution pertaining to the agenda item is incomplete or not in its proper
- E. Consent Agenda.

- 1. The consent agenda is a bundle of items that is voted on without discussion. Agenda items that can be moved to the consent agenda are those that are non- controversial, reoccurring and/or routine, or have been vetted through a subcommittee and/or legal
- 2. Any Business Committee member can request to move items from the agenda to the consent agenda, or to move items from the consent agenda for further discussion and open voting.
- 3. A list of consent agenda items will be circulated among the members of the Business Committee for voting and the Secretary will certify the list as the official vote.

### Art. IV - Section 8. General Council Agenda The following criteria are established to facilitate

proper vetting and discussion of General Council items while allowing the Secretary to meet Constitutionally mandated posting deadlines.

- A. Items to be considered for inclusion on the published agenda must be submitted to the Secretary by 11:59 p.m. on the fifth Tuesday before the annual General Council meeting.
- B. The Business Committee will review and approve the proposed agenda at the next regular meeting.
- C. The proposed General Council agenda will be posted and advertised in a special edition of the Nugguam and/or any other publication formally designated by the Business Committee for public notice no later than ten (10) days prior to the meet-
- D. Proposed Constitutional amendments must be submitted no later than 45 days prior to a General Council meeting to allow for review and posting notice at least 30 days before the meeting.

### Art. IV - Section 9. Meetings

The purpose of meetings of the Quinault Business Committee is to conduct official Tribal business, including but not limited to presentations and the adoption of ordinances, regulations, resolutions, contracts, agreements, and budgets. All matters brought before meetings of the Quinault Business Committee shall be recorded, transcribed, and presented by the Secretary or designated Officer for approval in a timely manner but no later than 30 days after the meeting. No meeting shall be recorded by the public without permission from each Business Committee member present.

Anyone presenting an item or who wishes to address the Business Committee directly must attend the meeting in person. Questions and comments will not be addressed over any virtual platform. The Business Committee may make an exception at its discretion.

Art. IV - Section 10. Quorum
A majority of six (6) Officers of the Quinault Business Committee shall constitute a quorum for the transaction of business. When a quorum has been established at any meeting, a majority of Officers present shall make a decision on any approved agenda item brought before them at such meetings, except as otherwise provided by law or by these By-Laws. If a quorum is not established, the meeting will be called to order by the President or designated Officer, a roll call of Officers in attendance will be taken, and the meeting will be adjourned by the President or designated Officer for lack of quorum. If a quo rum is not established, it will be reflected on the next Business Committee minutes.

### Art. IV -Section 11. Order of Business

All regular meetings of the Quinault Business Committee will be conducted in the following order of business:

- A. Legal Session;
- B. Meeting called to order by the President or
- designated Officer:
- Invocation;
- D. Roll Call; E. Ascertainment of a quorum;
- F. Review of the minutes from a regular meeting, special meeting, and/or emergency meeting;
- G. Approval of the minutes by vote;
- H. Approval of agenda; Special request and introduction of
- guest(s) (limited to 10 minutes); Information Items:
- K. Oral Reports and Presentations; (shall be no longer than 10 minutes apiece);
- Reading of Consent agenda and approval of Consent agenda by individual officers;
- M.Action Items;
- N. Executive Session; O. Open session if needed;
- P. Adjournment.

If order of business is not completed by eleven o'clock p.m. (11:00 p.m.), the Quinault Business Committee meeting may recess and reconvene within twenty-four (24) hours.

# Art. IV - Section 12. Voting All Officers of the Quinault Business Commit-

tee have the right to vote on all issues properly presented and placed before them. Issues to be voted on shall be made in the form of a motion properly seconded and recorded. Officers who vote against or abstain from voting on a motion will be recorded. During discussion only, an Officer may request for a matter of record their reasons for their vote. Officers of the Quinault Business Committee who are recorded as being present at a meeting but who are not present at the time a motion is voted on will be recorded on as having abstained.

### Art. IV - Section 13. Attendance

All Officers should prioritize attending regular Business Committee meetings. Any absence from a Business Committee meeting must be reported to the Secretary prior to the meeting, and the reason must be acceptable to the Business Committee in order for the absence to be excused. Failure to report to the Secretary will

result in an unexcused absence. If the circumstances prevent the Officer from reporting prior to the meeting, the Officer may ask to be excused at the next regular meeting during review of the minutes. Any Officer who is absent from three consecutive regular Business Committee meetings without excuse shall be removed from

### **ARTICLE V - PUBLIC HEARINGS**

Where the Constitution or laws of the Quinault Indian Nation require that the Quinault Business Committee shall hold a public hearing, the hearing shall be conducted under procedures adopted by the Business Committee to govern public hearings. In the absence of such procedures or where those procedures refer to these By-Laws, public hearings shall be conducted as follows: The Secretary will act as the Public Hearing Officer, unless the Business Committee in its discretion appoints another officer. At least one Quinault Business Committee member shall be present at each public hearing. The primary responsibility of the Public Hearing Officer shall be to issue proper notice on the public hearing, prepare all public hearing materials, and record public hearing testimony. The Public Hearing Officer will either provide a written summary of comments to the Quinault Business Committee or, if the public hearing was related to new or amended codes, assist the Office of the Attorney General in bringing the code(s) forward for enactment. The Public Hearing Officer shall impose reasonable time limits on the presentation of oral testimony, and shall require that comments which cannot be orally submitted in the allotted time be submitted in writing within seven days after the public hearing. Notice on all public hearings shall be posted in Taholah, Queets, and Amanda Park, as well as the Quinault Business Committee agenda when applicable. Additional notice at the discretion of the Quinault Business Committee may be published and provided to the interested individuals.

### **ARTICLE VI - DUTIES OF OFFICERS** Art. VI - Section 1. President

The President is the Chief Executive Officer of the Quinault Indian Nation. The duties of the President are:

- A. Preside at all meetings of the Quinault Business Committee and Quinault Indian Nation General Council;
- B. Oversee the strategic direction of the Quinault Indian Nation;
- Designate an Officer to chair official meetings in the absence of the President or Vice President.
- D. Sign all official papers and documents approved by the Quinault Business Committee or Quinault Indian Nation General Council, unless some other person is specifically authorized to do so by a majority vote of the Quinault Business Committee;
- E. Direct the implementation, administration and enforcement of all laws passed by the Quinault Business Committee;
- Act as the principal Officer representing the Quinault Indian Nation in establishing, maintaining, and furthering government to government relations with Federal, State, and Local Governments;
- G. Appoint a Parliamentarian, who is not an Officer of the Business Committee or is a non voting member of the committee/ council, to maintain order at:
  - Quinault Indian Nation General Council meetings;
- Special Ğeneral Council meetings;
- 3. At the President's or presiding Officer's discretion, Quinault Business Committee meetings.

The President has the authority to delegate any of the duties in this Section 1 to any other Officer as well as the authority to assume or delegate the duties and responsibilities of another Officer as circumstances require.

### Art. VI - Section 2. Vice-President

- A. The Vice-President shall assume all Presidential duties delegated to him or her by the President.
- B. The Vice-President shall serve as the Chief Executive Officer of the Quinault Indian Nation in the absence of the President or in the event the President is unable or incapable of carrying out the duties of that office. The President is declared absent when he or she leaves the Quinault Indian Nation boundaries and does not intend to return within twenty- four (24) hours. The President is considered incapacitated when for medical or other reasons, he or she is unable to carry out the duties of that
- C. The Vice- President shall perform all duties of the President from the time the President resigns, dies, or is removed from Office until the Quinault Indian Nation General Council elects a new President at their next Annual Meeting.

### Art VI - Section 3. Secretary

The duties of the Secretary are to:

- Keep accurate minutes and records of all meetings of the Quinault Business Committee and Quinault Indian Nation General
- Have the care and custody of the Quinault Indian Nation Seal and the authority to affix the Seal on all official documents requiring such Seal;
- certification of official actions, including approval and publication of constitutional amendments; Receive all information pertaining to issues

before the Quinault Business Committee

C. Establish and implement procedures for

or Quinault Indian Nation General Council; Prepare an agenda for each Quinault Business Committee or Quinault Indian Nation General Council meeting pursuant to criteria established by the Quinault Business

Committee and post notice of such meet-

- F. Assemble and make available all printed information required by the Quinault Business Committee or Quinault Indian Nation General Council prior to each meeting;
- Prepare the minutes of each Quinault Business Committee meeting and present them in a timely manner but no later than 30 days after the meeting for approval;
- Prepare the minutes of each Quinault Indian Nation General Council meeting within 90 days of adjournment of such meeting and present them to the Business Committee at the first regular meeting following completion for final discussion, approval, and inclusion in the next Annual General Council Report;
- Have published all matters required by law to be published in appropriate public places and in the media.
- Plan or caused to be planned all General Council meetings;
- Immediately following the meeting, distribute or cause to be distributed to the Quinault Indian Nation administrative bodies and judiciary all Business Committee policies and directives.

### Art. VI - Section 4. Treasurer

The duties of the Treasurer are to:

- A. Have care and custody of all funds and assets of the Quinault Indian Nation with the exception of land, water, and wildlife;
- B. Disburse funds in his or her care and custody as ordered by resolution of the

- Quinault Business Committee provided that such funds are on hand and have not previously been encumbered;
- C. Dispose of property and other assets in his care and custody as ordered by resolution of the Quinault Business Committee;
- D. Review and oversee financial affairs of the Quinault Indian Nation and initiate audits when necessary;
- E. Obtain the financial records of any Quinault Indian Nation National Department, Agency, Commission, Enterprise, Contract, or any other entity of the Quinault Indian Nation;
- F. Immediately inform the Quinault Business Committee if the Treasurer learns or is informed that previously committed funds are not actually available and provide recommendations for appropriate action;
- G. Provide a quarterly report to the Quinault Business Committee reflecting the overall financial condition of the Quinault Indian Nation at the second regular meeting following the end of each calendar quarter;
- H. Provide a report reflecting the overall financial condition of the Quinault Indian Nation at each Annual Meeting of the Quinault Indian Nation General Council;
- Provide other financial reports that may be requested by a majority vote of the Quinault Business Committee.
- J. Post the national budget on a quarterly basis in accordance with the Quinault Constitution, Article V, Section 3(i).

### Art. VI - Section 5. Councilperson

Councilpersons are Officers of the Quinault Business Committee and shall:

- A. Make up the legislative body of the
- Quinault Indian Nation's government; B. Carry out Article III of these By-Laws;
- C. Oversee and carry out all delegated responsibilities and report these activities to the Quinault Business Committee.

### Art. VI - Section 6. General Duties of an Officer

- A. Attend all meetings; B. Vote on all issues before the Quinault Business Committee;
- Listen to the voice of the Quinault Indian Nation people;
- D. Inform the Quinault Indian Nation people of all official actions taken by the Quinault Business Committee;
- E. Bring agenda items before the Quinault Business Committee;
- F. Be appointed to and serve on sub-committees of the Quinault Business Committee;
- G. Be appointed to and serve on other committees as determined by a resolution of the Quinault Business Committee;
- H. Perform such other duties as designated by a majority vote of the Quinault Business Committee;
- Must follow any policies, handbooks, rules, or governing documents passed by resolution of the Quinault Business Committee.

### **ARTICLE VII - COMMITTEES**

The Quinault Business Committee may estab-

- A. Purpose and objective of the committee;
- B. Time frame in which the committee will act; Duties, responsibilities, and authority of the committee;
- D. Reporting requirements;
- E. Members of the committee and its chairperson.

The President shall have the power to appoint a chairperson to a standing, special or sub- Committee.

### **ARTICLE VIII - AMENDMENT**

The Quinault Business Committee may amend these By-Laws by a two-thirds (2/3) majority vote of nine (9) Officers at any regular meeting after a public hearing on the proposed amend-

### **ARTICLE IX - OATH OF OFFICE**

Upon election or appointment, new Officers of the Quinault Business Committee shall take an Oath of Office and be sworn in by the Chief or Presiding Judge of the Quinault Indian Nation. The Oath of office shall be as follows:

HEREBY SOMEMNLY SWEAR (or affirm) that I shall preserve, support, and protect, the Constitution, By-Laws, Tribal Code of Laws, and the Treaty of Ólympia of 1856, of the Quinault Indian Nation to the best of my ability, so help me God."

# The Bald Eagle is now the US National Bird

Public Law No: 118-206



The bald eagle, a symbol of the power and strength of the United States for more than 240 years, earned an overdue honor: It officially became the country's national bird.

On December 23rd, President Joe Biden signed into law legislation sent to him by Congress that amends the United States Code to correct what had long gone unnoticed and designate the bald eagle — familiar to many because of its white head, yellow beak and brown as the national bird.

The bald eagle has appeared on the Great Seal of the United States, which is used in official documents, since 1782, when the design was

finalized. The seal is made up of the eagle, an olive branch, arrows, a flag-like shield, the motto "E Pluribus Unum" and a constellation of stars.

Congress that same year designated the bald eagle as the national emblem, and its image appears in a host of places, ranging from documents and the presidential flag to military insignia and U.S. currency, according to USA.gov.

But it had never been officially designated to be what many had just assumed it was — the national bird.

As I've said many times over the past year, these lands belong to We the People, not the powerful few. As Commissioner, I promise to safeguard and steward these lands, waters, and forests for the benefit of all Washingtonians.

Moving forward, I can't wait to work with you and work for you, to learn from you and listen to you, and to manage these lands for both present and future generations. Thank you all for the trust you have placed in me.



# Today's youth are tomorrow's salmon stewards

As tribal leaders, we are looking ahead to the next seven generations of environmental stewards to protect salmon, shellfish, wildlife and plant re-

It is our responsibility to provide young leaders with the tools to care for the natural resources our ancestors worked so hard to protect.

As part of the federal trust responsibility to uphold tribal treaty rights, the Northwest Indian Fisheries Commission has partnered with the National Oceanic and Atmospheric Administration (NOAA) to create a workforce development workgroup to help guide tribal members into careers in environmental stewardship.

"Our objective is to support tribal youth to go into fishing, conservation management and science careers," said Dan Tonnes, workforce development specialist for the NOAA Fisheries West Coast Region. "The very experienced tribal folks are retiring and looking for younger tribal members to take their place, but we need to connect them with the educational and career pathways to take advantage of these opportunities."

In partnership with the Tulalip Tribes, the workgroup organized the first Native Youth Salmon Summit in October, bringing together more than 70 students to celebrate salmon culture and learn about potential careers in salmon conservation and recovery.

A highlight of this summit was a job fair where representatives from nearly 50

colleges, government agencies and nonprofits connected with students, showing a wide variety of career options.

In December, the workgroup offered a webinar to share career development opportunities at NOAA, Washington Sea Grant and the U.S. Fish and Wildlife Service. Nearly 40 people attended,

including high school and college students, as well as young people starting their careers.

Working for federal agencies is just one option for our young leaders. The aim of the workgroup is not to create a career pipeline, but instead a braided river with many pathways, including careers in tribal natural resources depart-

We're bringing together representatives from tribes, weaving a network to share successes and expand programs that provide tribal members opportunities to work for their own communities.

Across the region, tribes are working to train the next generation of environmental stewards.

The Nisqually Indian Tribe partnered with Northwest Trek Wildlife Park to create a nature engagement fellowship. As the first fellow, Nisqually elder Rose Wells mentored tribal youth at the park, teaching them about potential careers working in na-

Taholah High School students worked side by side with the Quinault Indian Nation to collect data and trap invasive European green crab. The students' work filled a budgetary gap in response to the state's declaration of emergency in Grays Harbor.

At Neah Bay High School, Makah tribal students operate their own fish hatchery. In addition to giving the students hands-on experience, the hatchery program has been integrated into lessons in social studies, English, science and media classes.

It's rewarding to see our students energized by these programs.

"We are all connected through salmon, and we all need to do our part to support salmon and each other," one student said of their key takeaway from the Native Youth Salmon Summit at Tulalip.

Another said the most rewarding part of the summit was "Engaging with Indigenous leaders and hearing that their perspectives and knowledge are being celebrated and intertwined with modern ways."

We look forward to more educational partnerships in the future. We're counting on the next generation to continue the work of managing our treaty-protected resources. That means staffing hatcheries, habitat restoration crews, data-gathering teams and other natural resources management positions.

The strength of our tribes needs to be called upon if we're going to win this battle. If we can get our youth involved, we can gain momen-



Hello everyone!

Some of you are aware that I am retiring from QIN Forestry but for those of you that have not heard, my last day working for Forestry will

be February 5th. Just a little background about myself and career history. I graduated from WSU with a B.S. Forest Management Degree in 1981. I started working for a forestry contractor in Kelso, Washington. doing all types of forestry work for two years. I then moved to Shelton, to work for a forestry contractor and installed seedling progeny test sites, was foreman of tree planting and broadcast burning crews and cruised timber for five years. I then received a job offer with the USFS at the Lake Quinault Ranger District and worked with the silviculture section inspecting tree planting crews and conducting stand exams or inventory work. In 1989 I noticed a job opening with the Quinault Indian Nation for the Regeneration Forester, I applied but did not get the job.

About four months later Dave Bingaman, Forest Manager at the time, wanted to know if I would be interested in applying for a position that would be the assistant to the Regeneration Forester (Tim Beyer at the time) and the Fire Management Officer (Rick Trudeau at the time). I said sure, and started working for the OIN on September 25, 1989. I could not have asked for better supervisors and mentors at the time between Tim and Rick. I learned a lot about contract administration, budgeting, crew dynamics, and a whole lot more about broadcast burning on the Reservation. Rick also mentored me to become a wildland firefighter crew boss, and I started taking 20 person crews from Taholah and Queets to fight wildfires off-reservation. We had the best crews and always came home safe. Tim later became the Silviculturist, and I applied for the Regeneration Forester position and started my new job contracting with tree nurseries, planting crews, conifer release crews and site preparation work. When Tim decided to move back home to be closer to family, I applied for the Silviculturist position and really enjoyed working with the Forest Development team, some still work for Forestry, and they are dedicated and hard-working staff. Later in my career the Forest Manager (Nancy Eldridge at the time) decided to retire, and I applied for the position and have been the current forest manager for the past seven years. I have a total of 44 years working in forestry and just over 35 years with QDNR.

During my time with the Forestry program, I have worked on the ID Team, helped produce two forest management plans, participated in four Indian Forest Management Assessment Team reports, became a member of the UW Stand Management Cooperative for silviculture research, responsible for thousands of acres of reforestation on harvest units and worked with nurseries over many

years to help provide the best seedlings for the various soil types found on the Quinault reservation.

Some of the many reasons that I stayed working for the QIN; I enjoyed working for a small organization, it gave me more opportunities and flexibility to try new silvicultural prescriptions, do some of my own research, working on the upper Quinault restoration project, the challenges that the landscape provided with the North Boundary Area, forested wetlands, poor soil conditions, and slash disposal techniques. Linda and I also plan to do some traveling and spending time with family and friends.

I will just say that as Forest Manager it has been an honor and privilege working for the Quinault Indian Nation. The QIN has an exceptional Forestry Staff and ID Team, they are some of the best and will continue to make Quinault a leader in forestry and natural resources, they are dedicated and hard-working people.

I hope that our paths will cross sometime in the future.



Antonio was hired in the early 90's as a forestry seasonal worker to work on the tribal tree planting crew, precommercial thinning crew, burning slash piles and became a wildland firefighter. Antonio was also a Camp Crew supervisor on wildfires, he provided the leadership and timekeeping for all the QIN members that were part of the camp crew to support the wildfire resources.

After years of demonstrating good work ethics and gaining experience, Antonio was promoted to assistant Foreman of the seasonal crew where he oversaw crew operations for quality assurance, training new members and provided leadership. Eventually Antonio became the crew supervisor and was responsible for the daily operations of the seasonal crew, timesheets, and personnel issues.

Antonio was always willing to take on new projects and was the one person you could rely on to get the job done and do it right.

Not too long-ago Antonio suffered a stroke that limited his physical capabilities but, in his mind, he was still 30 years old and wanted to keep working in some capacity for forestry. Forestry had a need to provide the Tree Improvement Technician at the QIN seed orchard with assistance on projects, so he was assigned to the seed orchard where he did an amazing job of providing year-round maintenance and cone picking in the fall.

Whenever I would assign projects to Antonio that may have seemed difficult, he would always say "Ok, let's go! He had such a positive attitude and worked just as hard as everyone else on the seasonal crew. He will be missed, and we wish Antonio and his family all the best in his retirement.

### The Upcoming **Annual Meeting**

The Business Committed today is typical of a pattern we've been following for three years. The pattern is one of frustration, mistrust, and indecisiveness because of the rapid growth and change that has occurred in our community.

the OEO 1967 Community Action Agency was the only funded program of the tribes with \$36,000 of federal funds. Since 1967 we have become totally involved in expansion and growth, which some refer to as the Quinault Reservation "Frankenstein Monster". We can't view 80 new homes, and \$4.5 million dollars of federal programs as a "monster".

If people today feel that the projects and programs Business Committee have generated are not the ideals of Indian people and beneficial to the Quinault Indian Community, we ask that they review our history. You don't have to go back too many years to see what real frustrations are. It's a matter of record – in the late 1950's and early 60's the moral problems our people faced. We're speaking of the high unemployment, the suicides and attempted suicides, the high drop-out rate of our youth in public schools. No one will really know the total answer of why the Quinault people went through those bad years. We could go on and on about the bad situations that have been created by the federal government, or someone else, but history cannot be changed. We should learn from our past and bury its mistakes.

In 1971 you elected a Chairman of the Quinault Tribe, who recommended to the Business Committee and stressed the need to centralize the then fast-growing tribal programs. Input was not only from the Business Committee, but from professional and nonprofessional staff. That was two and a half years ago. Since then, the Business Committee and Indian staff personnel have been to many workshops and meetings trying to address the problem of an organizational structure that we would all understand, and which would work to satisfy our needs.

We believe there is no organizational structure or government that would satisfy everyone's problem. We have been kicking the subject of a central government around for five years and we don't seem

to be any further along on the subject than when we started. We feel the reason we're still on the starting line is that people are letting their own personal hang-ups get in the way of good, sound thinking and judgement.

We're sick and tired of hearing that an idea or recommendation is no good for us because it is a white, black, or yellow idea. We think it's time you people look into your own personal hang-ups and prejudices and recognize that the Quinault Reservation is an under-developed nation and that we need all the help we can muster. We should trust all people until proven otherwise.

The Business Committee consists of duly elected people who you, the electorate have placed your respect and faith in, to look out for your interests.

We're tired of discussing and debating organization. We're setting 10:00 a.m., March 8, 1975, for a special meeting to review the proposed Tribal Constitution. There will also be an announcement from the Queets Office concerning a constitution meeting there.

The Annual meeting of the Quinault Tribe will be on March 22, 1975, instead of March 29, because of the Easter Holiday. Both meetings will be at the Taholah School Gymnasium. They are going to be your meetings, your future, your nation, that's on the line. You will decide and you will make the decision as to the coming years of the Quinault Indian People.

### **Sub-Committee Disbanded** for Business Committee

In mid-January at a regular Business Committee meeting, the council decided to break down into subcommittees on a month trial basis in the hope of getting more in-depth knowledge on subjects of concerns for the Quinault Tribe. On February 10, 1975, the Tribal Business Committee decided to disband sub-committees. The entire Business Committee will now meet at the regularly

scheduled times.

### Fisheries Yield 4,500 lbs. of **Pan-sized Coho Salmon**

Two pens (approximately 4,500 lbs.) of pan-size coho were graded for the market. These pan-size fish were moved to the Seafood Pocessing Plant from pen rearing at Lake Quinault.

In a test fishery at pen rearing site, 30 adult steelhead (25 females) returning from a meager plant and escapement have been caught. This is extremely promising as 75,000 eggs, which could have been unavailable for planting and other use have now been reclaimed for use. The value of pen rearing to the steelhead fishery can now be documented as their fish returned to the place at which they were reared.





### **Quinault Tribe One of First** to Implement Court Decision

Quinaults are one of the very first to implement Judge Boldt's decision of off-reservation fisheries. In this unique decision, the Quinault Tribe is entitled to 50% of harvestable fish and also allowed to set up self-regulation authority in our "usual and accustomed" fishing grounds.

Quinault off-reservation fishing has been mostly on the Humptulips River. Three tribal patrolmen have been hired to uphold the regulations set up by the Quinault Tribe: Ted Trom, Earl Ralston and Fred Koontz. Jeff J. Fujioka was hired as a fisheries biologist, and there are eight tribal fishermen. Through January 31, the fishermen have caught about 1,250.

Permission to obtain steelhead 200,00 from Eagle Creek National Hatchery was granted by the U.S. Fish & Wildlife Service. These fish will be used by the off-reservation fisheries program.

### American and European Beach Grass are changing the habitats along our coastline



This is a view looking north from the Pacific Beach State Park. This area was all open sandy beach until the late 1980s.

Much of the coastal area south of Point Grenville is now covered with two non-native beach grasses. These grasses are pushing out all native coastal sand dune plant species. They create larger and more permanent sand dunes than the native dune plants would, which permanently change the hydrology and ecology of the habitat behind the dunes. Beach grasses are

very prone to wildfires. On many sections, Sitka spruce is starting to grow, but two previous wildfires here, destroyed them. The grasses are also creating a wet land behind the dunes.

These non-native beach grasses were planted to hold sand and protect infrastructure along the West Coast of North America. Due to this important role, they are not required for control, so agencies, can choose to leave beach grasses on their properties, as protection from wave action, storms, blowing sand, and shifting dunes.

European beach grass (Ammophila arenaria) is native to the banks of the coasts, lakes, and rivers of Europe, the Mediterranean, and Eurasia. American beach grass (Arenaria breviligulata) is native to the East Coast of North America along the Atlantic from North Carolina to Newfoundland, and inland through the Great Lakes.

European beach grass was introduced to the West Coast in the 1800s but wasn't planted widely along the West Coast until the early 1900s, for dune stabilization, and has since been

considered naturalized in many places By the 1950s it had spread from Mexico to Canada

American beach grass may have first been planted on the West Coast in 1935, along the Clatsop Peninsula, near the mouth of the Columbia River. In the following years, there were further plantings of it along Washington's coast, like near Ilwaco in Southwestern Washington.

It wasn't until 2012 that hybrids of these two grasses were first suspected to be present, in our region.
