2025 SPRING /SUMMER FISHERY SUBSISTENCE FISHING REGULATION – 01

TO: Queets Fishermen, Quinault Fisheries Enforcement

Date: April 3, 2025

SUBJECT: Queets River Spring/Summer Sockeye Subsistence Fishery- Stat Weeks 19-24

FISHERY/PURPOSE: This regulation establishes the Queets subsistence **Set Net** fishery schedule for weeks 19-25 and the subsistence **Hook and Line** season May 1, 2025 – June 16, 2025.

SET NET AREA: Only the lower 6 grounds at the mouth of the Queets River are open to set netting.

Gear: Set nets only. Maximum allowable mesh size for this fishery is 5 inches. Nets must be clearly marked with personal identification numbers on the outer corks or buoy.

SEASON (HOOK AND LINE, ONLY) : May 1, 2025 – June 16, 2025

HOOK AND LINE AREA: The Queets River from the mouth to the Highway 101 bridge is open to subsistence hook and line fishing.

LIMITS: 2 Sockeye using hook and line pole fishing gear. Incidental catch limits for other species are provided under the Queets River sport regulation.

Hook and line pole fishing gear is allowed between the Queets River and Highway 101 bridge. The use of salmon eggs/cured roe is prohibited.

PARTICIPATION: Only individuals whose treaty I.D. numbers are listed on the approved roster of fishers are eligible to fish with gillnet gear. Set net participants must notify the Queets River Committee of the ground they will be fishing during any of the times authorized above. Quinault members are allowed to use hook and line methods within the season, area and daily limits above.

Reporting: All catches are to be reported to the Queets office secretary. A daily catch sheet will be posted at the Queets office for recording daily catch. Please report the date of the catch and number of each species.

QDFi and the Committee should meet in Weeks 21 and/or 23 to review fishery performance and run status and make any necessary adjustments to the remaining schedule. Of course, an emergency meeting can be called at any time as needed.
