SUBJECT: Ceremonial Fishing on the Queets River - **Stat Wk 51.**

FISHERY/PURPOSE: Ceremonial Fishery on the Queets River for 10 fish.

SEASON: To commence Thursday December 19th, 2024, at 6:00 am and end December 20th, 2024 at 4 pm.

AREA: Queets River within the Quinault Indian Reservation Boundary.

LIMITS: The fishery is open to catch 10 fish.

GEAR: The minimum allowable mesh size is 5½ inch. All nets must be clearly marked with personal identification numbers on the outer corks or buoy.

PARTICIPATION: Enrolled Quinault members Darren Sansom, Steve Sansom and Kieth Butler.

REPORTING: All catch shall be reported to the QDNR permits office in Taholah at Ext. 7372 within 72 hours of capture or to mycatch@quinault.org.
